entertain them. At Hope Lodge each patient and meet with other families staying there also. If the patient is in the hospital, their care giver can still stay at Hope Lodge. Transportation is provided as need to get to the hospital and back. This saves time and money with parking. All of this free to the family. Worldwide in 2024 15,649 nights were used. As we raise money, \$100 will fund one night at Hope Lodge.
