

## MV approves budget, contracts, calendar

The tax levy will be reduced after the Maquoketa Valley School Board approved their 2025-2026 budget April 23.

At an earlier budget hearing, the board proposed a levy rate of 9.75330 per \$1,000, based on a 3% State Supplemental Aid (SSA) number from the Iowa Legislature, dropping the Maquoketa Valley levy four cents from last year.

Instead, the legislature approved a 2% SSA figure, which will reduce Maquoketa Valley's rate even lower, with the final figure determined by the state's Department of Management.

The board also approved the collective bargaining agreement with the Maquoketa Valley Education Association (MVEA). The two sides were in the second year of a two-year agreement which called for a 5% increase, amounting to a total package of approximately \$260,000.

The board approved compensation recommendations for administrative and classified staff for the 2025-2026 school year. The superintendent will be paid \$157,500, which is broken down as \$137,500 for superintendent and an additional sharing incentive of \$20,000.

Classified staff will receive their step and lane as well as a 3.5% increase. Paraprofessionals completing their paraprofessional certification will receive an additional \$1 per hour.

The board approved the 2025-2026 school calendar. The first day of classes for students will be Monday, Aug. 25, with the semester ending Friday, Jan. 9. The second semester will begin Tuesday, Jan. 13 and end Wednesday, May 27.

Graduation will be Wednesday, May 20.

they generated power and ran noisily while it was raining, they won't use that," she said.

"That's a sidestep because they aren't following the pro-

tocol they said they would follow when we signed the easement for them to do the repower and they are not following the permit from Delaware County."

Beswick said Greenbacker

officials she has spoken with said noise reduction software, which could help with reducing noise, will not be available until August or September.

"They are at the point of saying something and not pro-

ducing it," she said. "I'm asking you as supervisors to please not accept that noise study they did because they didn't follow the protocol when they got the permit. Let them know

they have to abide by county

ordinances just like everybody else."

Supervisors will direct the Delaware County Assistant Attorney about reaching out to Greenbacker concerning the issue.
