NOTICE OFFICIAL NOTICE **BEFORE THE UTILITIES** COMMISSION OF THE STATE OF IOWA TO THE CITIZENS OF JACKSON COUNTY:

Notice is given that ITC Midwest LLC, Cedar Rapids, Iowa, pursuant to Iowa Code chapter 478, has filed a petition with the Iowa Utilities Commission (IUC) for extension of franchise to maintain and operate an electric transmission line setting forth the following as the maximum voltage, starting points, routes, and termini of the existing line: EXHIBIT A

69,000 Volt Nominal (72,500 Volt Maximum)

Electric Transmission Line Jackson County, Iowa

The west end point of this line is at a point of electrical connection with an ITC Midwest LLC (ITC) electric transmission line located near the southeast corner of Section 26, Township 84 North, Range 2 East of the 5th Principal Meridian, Jackson County, Iowa, and the west terminus of this line will be at a point of electrical connection within Central Iowa Power Cooperative's Maquoketa Substation located in the west half of the Northwest Quarter of Section 26, Township 84 North, Range 2 East of the 5th Principal Meridian, Jackson County, Iowa

The east end point of this line is at a point of electrical connection with an ITC electric transmission line located in the Northeast Quarter of the Northeast Quarter of Section 36, Township 84 North, Range 2 East of the 5th Principal Meridian, Jackson County, Iowa, and the east terminus is at a point of electrical connection within Maquoketa Municipal Electric Utilities Allen Street Substation located in the Southwest Quarter of the Northwest Quarter of Section 30, Township 84 North, Range 3 East of the 5th Principal Meridian, Jackson County, lowa, within the City of Maquoketa, Iowa.

This line begins at a point of electrical connection with an



ITC electric transmission line located in the public road right of way of the west margin of 184th Avenue, approximately 0.01 mile north and 0.01 mile west of the southeast corner of Section 26, Township 84 North, Range 2 East of the 5th Principal Meridian, Jackson County, lowa; thence south in the public road right of way of the west margin of 184th Avenue along the east line of said Section 26 and Section 35, said township and range, to a point located in the public road right of way of the west margin of 184th Avenue, approximately 0.24 mile south and 0.01 mile west of the northeast corner of said Section 35, a distance of approximately 0.25 mile; thence east in the public road right of way of the west margin of 184th Avenue, crossing 184th Avenue, to a point located in the public road right of way of the east margin of 184th Avenue, approximately 0.24 mile south and 0.01 mile east of the northwest corner of Section 36, said township and range, a distance of approximately 0.02 mile; thence south in the public road right of way of the east margin of 184th Avenue along the west line of said Section 36, crossing Prairie Creek to a point located in the public road right of way of the east margin of 184th Avenue, approximately 0.35 mile south and 0.01 mile east of the northwest corner of said Section 36, a distance of approximately 0.11 mile; thence west in the public road right of way of the east margin of 184th Avenue, crossing 184th Avenue, to a point located in the public road right of way of the west margin of 184th Avenue, approximately 0.35 mile south and 0.01 mile west of the northeast corner of Section 35, said township and range, a distance of approximately 0.02 mile; thence south in the public road right of way of the west margin of 184th Avenue along the east line of said Section 35, to a point located in the public road right of way of the west margin of 184th Avenue, approximately 0.25 mile north and 0.01 mile west of the southeast corner of said Section

35, a distance of approximately 0.40 mile; thence east in the public road right of way of the west margin of 184th Avenue, crossing 184th Avenue, to a point located in the public road right of way of the east margin of 184th Avenue, approximately 0.25 mile north and 0.01 mile east of the southwest corner of Section 36, said township and range, a distance of approximately 0.02 mile; thence south in the public road right of way of the east margin of 184th Avenue along the west line of said Section 36, to a point located in the public road right of way near the center of 100th Street, approximately 0.00 mile south and 0.01 mile east of the southwest corner of said Section 36, said point being on the Jackson/Clinton county line a distance of approximately 0.25 mile; thence traveling easterly in Clinton County this line begins again at a point of electrical connection with an ITC transmission line located in the public road right of way near the center of 100th Street, on the Jackson/Clinton county line, approximately 0.00 mile south and 0.01 mile east of the southwest corner of Section 31, Township 84 North, Range 3 East of the 5th Principal Meridian, Jackson County, lowa; thence north crossing 100th Street and continuing north in the public road right of way of the east margin of 200th Avenue along the west line of said Section 31, to a point in the public road right of way of the east margin of 200th Avenue, approximately 0.06 mile north and 0.01 mile east of the southwest corner of said Section 31, said point being on the south corporate limit line of Maguoketa, Iowa, a distance of approximately 0.06 mile; thence continuing through the corporate limits of Maquoketa, Iowa this line begins again at the southern corporate limits of Maquoketa, lowa, located in the public road right of way of the east margin of 200th Avenue approximately 0.21 mile north and 0.01 mile east of the southwest corner of said Section 31; thence north in the public road right of way of the east margin of 200th Avenue along the west line of said Section 31 to a point in the public road right of way of the east margin of 200th Avenue, approximately 0.42 mile north and 0.01 mile east of the southwest corner of said Section 31, said point being on the south corporate limit line of Maquoketa, Iowa, a distance of approximately 0.21 mile; thence continuing through the corporate limits of Maguoketa, lowa this line begins again at the southern corporate limits of Maguoketa. Iowa. located in the public road right of way of the east margin of 200th Avenue approximately 0.41 mile south and 0.01 mile east of the northwest corner of said Section 31; thence northwesterly in

nue crossing 200th Avenue, to a point in the public road right of way of the west margin of 200th Avenue, approximately 0.40 mile south and 0.01 mile west of the northeast corner of Section 36, Township 84 North, Range 2 East of the 5th Principal Meridian, Jackson County, lowa, a distance of approximately 0.02 mile; thence north in the public road right of way of the west margin of 200th Avenue along the east line of said Section 36 to a point on private property adjacent to the public road right of way of the west margin of 200th Avenue approximately 0.30 mile south and 0.01 mile west of the northeast corner of said Section 36, a distance of approximately 0.10 mile; thence north on private property adjacent to the public road right of way of the west margin of 200th Avenue along the east line of said Section 36 to a point in the public road right of way of the west margin of 200th Avenue, approximately 0.25 mile south and 0.01 mile west of the northeast corner of said Section 36, a distance of approximately 0.05 mile; thence north in the public road right of way of the west margin of 200th Avenue along the east line of said Section 36, to a point of electrical connection with an ITC transmission line located in the public road right of way of the west margin of 200th Avenue, approximately 0.19 mile south and 0.01 mile west of the northeast corner of said Section 36, said point being on the south corporate limit line of Maquoketa, Iowa, a distance of approximately 0.11 mile.

The total distance of the 69kV line segment is approximately 1.62 miles.
