#### Senior insurance volunteers to serve Jackson County

SHIIP volunteer counselors will continue to see clients in person at Jackson County Regional Health Center (JCRHC) or call clients to discuss options during open enrollment.

To make an appointment call (563) 652-4000 and leave a message with your name and your phone number. A volunteer will return the call within 24 to 48 hours, Monday through Friday.

JCRHC will not schedule clients in Bellevue during the open enrollment, which runs Oct. 15-Dec. 7. Coordinators with the Senior Health Insurance Information Program and Senior Medicare Patrol (SHIIP-SMP) are continuing to seek a volunteer counselor to serve the area in the future.

JCRHC is an official sponsor of the SHIIP-SMP programs, a service of the State of Iowa. SHIIP-SMP volunteers provide local, in-depth, and unbiased one-toone insurance counseling and assistance at no cost to Jackson County, Medicareeligible individuals, their families, and caregivers. SHIIP-SMP also provides community outreach on Medicare and how to guard against Medicare fraud.

SHIIP-SMP helps consumers navigate the complexities of Medicare and saves them money by explaining Medicare benefits and rights; comparing Medicare supplements, Medicare Advantage, and other drug plans; understanding Medicare enrollment periods and preventative benefits; finding assistance programs that help with Medicare costs and Medicare drug plans; and learning how to protect themselves and their loved ones from Medicare scams.

## Industrial Park gets grant funds from IEDA

Jackson County is among five recipients of the Iowa Rural Certified Site Initiative (IRCSI), a competitive grant program supporting the development of project-ready industrial locations in Iowa's smaller communities.

The program falls under the Iowa Economic Development Authority (IEDA).

The Jackson County Economic Alliance received funding in the amount of \$27,050 for the Highway 61 Industrial Park in Maquoketa.

A total of \$133,528 in matching funds will be distributed to assist with due diligence activities required for site certification a key step in attracting new business investment and quality jobs. The funding reimburses costs for required reports and studies such as environmental assessments, geotechnical investigations and cultural resources surveys. had similar figures, topsoil moisture rated 33% short and 10% very short and subsoil rated 44% short and 11% very short. West central lowa had topsoil moisture conditions fairly close to the average for the state, but 21% of subsoil in the region rated very short of moisture.

Despite the less than desirable soil moisture conditions, the regions were on par with the state averages for crop emergence for corn, 97% emerged, and soybeans, 93% emerged. Six percent of soybeans across the state were blooming.

Corn and soybean crops continue to rate well, with both at more than 80% good to excellent condition.

Hay condition was similarly rated across the state and 88% of hay acres have undergone a first cutting, and 16% have already had a second cutting.

Oats also rated well with an average of 19% coloring. Pasture condition dropped slightly from the week prior to 69% good or excellent and no major livestock concerns were reported.

### Fraudulent text messages scamming lowans

The Iowa Department of Transportation is warning consumers of recent text scams that are occurring in Iowa and across the country.

Fraudulent text messages appearing to come from the Iowa DOT or "DMV" are targeting recipients with false claims of unpaid traffic violations. Individuals are also receiving fraudulent Iowa DOT-generated text messages stating that they have an unpaid toll or registration fee. Both types of texts ask recipients to click on a link to provide personal information as well as credit card numbers. Many times, the link will lead to a website that looks like the Iowa DOT's website.

The lowa DOT does not send out fee collection reminders via text, and will never text customers asking for private or financial information. Payment requests from the lowa DOT are made through personal transaction, via physical mail, or through an online transaction initiated by the customer. The lowa DOT does not collect tolls on any of their roads or bridges.

### Crop and soil conditions remain stable despite weather

lowa crops continue to rate well, though average rainfall across lowa last week was less than seven-tenths of an inch and some regions suffered from damaging hail storms.

While the average soil moisture conditions rate 70% adequate for topsoil and 60% adequate for subsoil conditions, some regions of the state have much drier conditions, according the crop progress and condition report prepared by U.S. Department of Agriculture.

In southeast lowa, topsoil moisture rated 34% short and 10% very short, and subsoil moisture rated 48% short. Southwest lowa

Report and delete unwanted text messages. A phone's "report junk" option should be used to report unwanted texts to your messaging app; they can also be forwarded to 7726 (SPAM).

While some government agencies use text messaging to contact customers, no government agency should direct individuals to share confidential or financial information through a text.

In Iowa, you might set up a Driver License appointment and receive a confirmation text, but you will always log into an Iowa DOT system with a username and password, not with a simple link.

Those who suspect they are victims of a text scam should consider filing a police report with the local law enforcement agency where you reside. They can speak to AARP's Fraud Watch Helpline and find Fraud Victim Support Groups (all ages accepted).
