Trump's plan to end the war in Gaza, and they will present the group's response to Egyptian and Qatari mediators on Wednesday, a source close to the process told CBS news on Tuesday.

The plan, which mr trump presented alongside israel prime minister benjamin netanyahu at the white house on monday, is a 20 point proposal which, if agreed to, would see a swift ceasefire in Gaza, the release of all The remaining hostages and a number of passionate prisoners in Israel. It says that within 72 hours of Israel publicly accepting this agreement. Including all hostages, alive and deceased will be returned.

Mr Trump's proposal does not include any immediate role for the PA in administering post-war Gaza, but it says the organization could eventually securely and effectively take back control of Gaza once it has implemented a series of reforms. The leaders of a number of muslim majority nations including the key states in the middle east, quickly signalled support for the plan. Jordan the united arab emirates,indonesia, pakistan, turkey, saudi arabi and qatar issued a joint statement welcoming mr trump sincere efforts to the end the war in gaza.
