Wettstein's appeal denied

By Karen Spurgeon, Publisher The Court of Appeals of Iowa on May 19, 2025 affirmed the sentence of Matthew Wettstein of Davis County after he appealed the sentence handed down on May 3, 2024.

On May 3, 2024 Wett-

stein was sentenced in District Court to two consecutive terms of incarceration and two concurrent terms of incarceration for a total of 20 years.

The sentence was handed down in response to four Class C felony charges for sexual abuse in the third degree between Sept. 1, 2020 through December 31, 2021. Wettstein pled guilty to the charges and was found guilty of the charges by District Court following his trial.

Wettstein appealed the sentence shortly thereafter, saying "the court abused its discretion when it relied on unproved or unprosecuted conduct as relayed in

the victim impact statements" given by K.W. and her parents.

Wettstein argued for a suspended sentence and probation in an appeal from the District Court to the Supreme Court of Iowa, which transferred the case to the Court of Appeals.

The Court of Appeals found the District Court "properly exercised its discretion" and affirmed Wettstein's sentence.

Davis County Sheriff Zach Dunlavy said Wettstein was transported from Davis County Jail to Oakdale Monday, June 9, for classification and assignment within the Iowa prison system.

Norris wins bid for asphalt overlay of square

The Bloomfield City Council approved a bid of \$738,768.50 Thursday night from Norris Asphalt of Ottumwa for an asphalt overlay of Franklin, Madison, and Jefferson Streets around the square plus one block off.

Though Norris was the only company to bid the project, the council was pleased the bid was lower than the engineer's original estimate of more than \$800,000 due to a decrease in the cost of asphalt.

The resurfacing project will take approximately a week — two days for milling and three days for laying the asphalt. The end date of the project is set for Oct. 15, 2025.

The meeting began with a public hearing on a budget amendment for FY2025. According to the notice of public hearing published in the Bloomfield Democrat, the amendment was needed because "more property tax was collected than estimated; grant proceeds were larger than anticipated; capital assets were sold that were no longer in use; SRF loan proceeds were granted for sponsored project; and transfers were completed to close out funds that were sitting idle from past completed projects.'

Also, on the expense side, "public safety was amended to cover additional expenses for a car; airport was increased for unexpected building maintenance as well as engineering for FY26 grant; library had unexpected repairs as well; P&A was increased to cover a new website; debt service was amended to cover streets plans; capital projects was increased to close out past streets project expenses; enterprise funds needed increased due to the increase in price for purchased power, building repairs and truck purchase. Transfers were also increased to close out past projects holding excess funds."

The council approved the resolution to adopt the budget amendment.

The third reading of water and demand electric rate increases was approved and new rates will go into effect July 1. Water rates were increased to \$10.66 per 1,000 gallons beyond the first 1,000 gallons used during a month. The demand electric rate is increasing to \$14

per kWh. Updates to the handbook for city employees included an increase in bereavement leave from two to three days for the death of a sibling and setting working hours for the Parks and Rec Depart-

ment to 8 a.m.-4:30 p.m. The council approved a resolution to set a date for a public hearing on the proposal to enter into a Development Agreement with Panos Holdings, LLC and SKP Industrial, LLC. This is the final step for Panos in securing a TIF Agreement with the city.

The council set a public hearing for June 19 to discuss selling parcel 01000053. City Administrator Tomi Jo day said the half-acre parcel is in a residential area on Lake Road and is owned by the city. "Plans were originally to get a grant and put a park there," she said.

The council was asked

to set a public hearing to give the public an opportunity to suggest uses for the half-acre parcel.

The council approved a
