Rump said staff have been working with the IDOT and 380 Express to evaluate the potential for a new bus stop in North Liberty at the new UIHC facility. The IDOT would like to hire a consultant to develop a scope of service and cost-share with 380 Express. Rump said the vanpool reserve account will be able to cover the \$10,000 Express.
