**PUBLIC NOTICE OF STORM WATER DISCHARGE**  
The City of Cedar Rapids plans to submit a Notice of Intent to the Iowa Department of Natural Resources to be covered under the NPDES General Permit No. 2 - "Storm Water Discharge Associated with Industrial Activity for Construction Activities." The storm water discharge will be from approximately 11 acres of construction activities to build 750 linear feet of levee, realignment of F Avenue NW and 1st Street NW, and relocation of existing or construction of new public utilities (water, sanitary, stormwater) and private utilities for the City's flood control system, located in Cedar Rapids, Iowa, in the SE ¼ of Section 20, T83N, R7W and SW ¼ of Section 21, T83N, R7W, in Linn County. Storm water will be discharged from 1 point source to the Cedar River. Comments may be submitted to the Storm Water Coordinator, Iowa Department of Natural Resources, 502 E. 9th Street, Des Moines, IA 50319. The public may review the Notice of Intent from 8:00 a.m. to 4:30 p.m., Monday through Friday, at the above address after it has been received by the department.
