

# ON-GOING COUNTY INVESTIGATION

David C. Nuam, by whose mailing address is at 1101 5th Avenue, Columbus Junction. Nuam is also listed as a contract buyer for a four and a half-acre site adjacent to the five-acre rural Columbus Junction property on Q Avenue.

A June 17 report in the Cedar Rapids Gazette indicated more than 40 Iowa Department of Health and Human Services (DHHS) officers were brought in from throughout the state to assist in the operation, which resulted in 88 children being placed into protective custody.

The children were eventually transported to the Wapello Methodist Church where they met with DHHS officials and released to parents, guardians, foster care or other state child protection officials.

In his June 20 email, Marquardt reported all the children had now been returned to their parents.

According to the department's sheriff's original June 16 press release and various published articles, the children had been attending the Shekinah Camp Glory and Kingdom Ministry of Rehab and Recreation.

The Gazette article reported Marquardt has said the ministry and camp were established in Louisa County in

2018. The article went on to report the ministry is a rehabilitation center to help members of the Burmese population with substance abuse problems.

Moines A Des Register article reported the Kingdom Ministry of Rehab and Recreation's website identified its mission is "Assisting individuals in breaking free from addiction through God's Word, offering food and shelter to those in need, and supporting individuals during fasting and prayer."

The Register article also reported the camp was to have run from June 8 to June 29. However, that was cut short after the law enforcement action, which was reportedly set in motion by one of the camp attendees.

A June 16 story filed by the Quad Cities' KWQC broadcast station, reported that Victor Bawi, the son of a minister at the church, said a 15-year-old from Texas called authorities because he did not want to be there.

The June 16 press release from the Louisa County Sheriff's Office did not specifically identify what led authorities to launch the operation, but did stress it "was based upon information and reports regarding child abuse

and endangerment."

Complaints about the ministry and camp have been received in the past, according to the June 17 Gazette article. In that story, Marquardt said his office had received calls of intoxicated subjects and children being near them.

In the same article, Fredonia Mayor R. Samuel Braden said the house at 1101 5th Avenue had been discussed at a city council meeting. Braden said the program was controversial and residents many had raised concerns.

Braden said the initial operation had only involved around 20 people, but later paperwork filed with the city showed 51 were now in the program, over twice the number approved by the city; and there was not enough staff to supervise everyone.

Continuing in the article, Braden said someone from the ministry had once broke into another person's house and started an altercation because he was drunk. Braden had gone on to explain in the article that racial motivations were behind the conflicts with the local Burmese community, among the largest in the state; and that racist graffiti had been left in the park telling the Burmese to go

home

"We have struggled with racism directed at the Burmese and that has clouded a lot of discussion here. There have been legitimate concerns as well in the issues of supervision and maintenance that David (Nuam) may have gotten himself in over his head," Braden was quoted in the article.

According to community and other local leaders, many of the Chin Burmese who now live in the Columbus Junction area settled here because they were able to find work in the local Tyson Food Plant.

Following the initial settlement of Burmese, it was learned Arthur E. Carson, the first Christian missionary to the Myanmar Chin state, had been born in Columbus City, cementing the community's ties to the area.

Meanwhile, Brian Thye, Louisa County sanitarian and zoning administrator, was also contacted June 19 and asked if either of his offices were involved the continuing in investigation because of possible environmental health or zoning issues.

Thye indicated he was involved but declined to provide any specific information and referred all questions to Marquardt.
