WHEREAS, it is desired to make appropriations for each of the different offices and departments for the fiscal year beginning July 1, 2025 in accordance with Section 331,434. Subsection 6. Code of Iowa.

NOW, THEREFORE, be it resolved by the Board of Supervisors of Louisa County, Iowa as follows:

Section 5. The auditor shall establish separate accounts for the appropriations authorized in Section 1, each of which shall report the status of such accounts to the applicable departments and officers (daily, weekly, monthly, quarterly) during the 2025-2026 budget year. 66
