Election Information

As a long time chairmen of the finance committee I have been involved in the budget process annually. The basic amount to fund our City is by annual taxes paid by the "residents of the City". This tax Rate is controlled/limited by the State. Many have the illusion that if the live or work near the City they pay taxes to the city which is incorrect. The City is also very fortunate to annually receive a nice stipend for perpetuity from the "Roundy Foundation", thanks to the Beryl Roundy estate. A third source is grant money from sources such as "Riverboat foundation", Louisa Development Group", and others via grants written by Council and Staff, additional funding is from utilities billing, licenses, and various fines.

The City Ambulance is basically a financially self-supporting entity that bills individuals, insurance, Medicare, and Medicaid for the services. Additional funding is received via Ground Emergency Medical Transportation (GEMT) and Emergency medical services (EMS) subsidies. As Chairmen of the Finance Committee my priorities are a balance budget that provides the best services to the City at a minimum impact to the resident tax payers.

8. What role should the community play in supporting our school district and the education of our children?

Community support is absolutely necessary!! The City of Columbus Junction council has long believed the success of our City is directly correlated to the success of our schools! The City welcomes our partnership with the Columbus school. The City makes an annual contribution to the School resource officer of \$10,000, plus and annual \$10,000 stipend to the pool. Several years ago the City made a standing offer of a \$200,000 contribution towards a new pool.

9. How do you, as a board member, feel about negative comments from either employees or teachers about the city or school which you are employed at on Facebook for all to see?

1. Please tell us a little bit about yourself and your ties to the community. If you could attach aheadshot that would be great!



Ι have lived in CJ since 2008, after moving from Muscatine when I began dating my now wife, Vicky Martin Dohrmann. Vicky grew up here, and her family has strong ties to the community, which has deepened my commitment to this community. Together we are raising three children—Isaac (24), Cambree (19), and Aiden (15). I currently work as an Advanced Maintenance technician with HNI.

Over the years, I've watched my wife volunteer her time with numerous community

groups, and seeing the impact of her efforts has inspired me to step forward as well. This community has given so much to my family, and I feel it is my turn to give back. I've grown to truly love living here, and I'm eager to find new ways to get involved and contribute to making CJ an even better place to live.

2. What are the top three things that need fixed/addressed with in our city? What do you think is currently going well in our community?

For me, the top three areas that need to be addressed in our community are:

- 1. Road conditions Our roads are showing wear and tear, and keeping them maintained is essential for safety, accessibility, and long-term cost savings.
- 2. Water main conditions We have experienced several water main breaks which have led to costly repairs, and service disruptions. Upgrading and maintaining this infrastructure is critical.
- 3. Community growth and engagement - In a small community like ours, it's important to focus on creating opportunities that keep people here and bring new families in. Whether that's through supporting local businesses, improving amenities, or encouraging volunteerism, strengthening community involvement is key to keeping CJ vibrant and sustainable for the future.

As far as what is going well in our community, I would have to say that we have some beautiful natural surroundings. The work that Bev Nielsen, Twyla Peters, and additional volunteers have done for our walking trails, parks, and swinging bridge is amazing. And it is great living in a community where we have volunteers like this that instill that local pride and tradition. When I moved here, I didn't realize how significant a celebration Columbus Day was - but the event has grown over the last several years thanks to the members of the Community Club and their dedication to showing how great this community is. I believe this pride in CJ is a huge asset to this little town – we have some very dedicated people.

3. What are the most pressing issues currently facing the success of our city?

Right now, one of the most pressing issues facing our town is the impact of the Highway 92 detour. With so many heavy trucks coming through, our roads are taking a lot more wear and tear than usual. That extra traffic not only speeds up road deterioration but also puts added stress on the sewer and water systems that run under those streets. We need to start planning now for the repairs that will be necessary once the detour ends,

including looking for grants and state aid to help cover the costs and ease the financial burden on the city

4. If elected, what are the priority issues you would want to address during your term?

If elected, my top priorities would be addressing road conditions and the longevity of our water mains. With the current detour routing more traffic through town, our roadways are experiencing added wear and will deteriorate faster if we don't stay ahead of maintenance. At the same time, repetitive water main breaks continue to disrupt daily life for residents and businesses.

- I believe focusing on these core infrastructure issues is essential because they affect everyone, every day. By investing in our roads and water systems now, we not only make daily life easier and safer, but we also strengthen the long-term foundation of our community. These are the mainstays that keep CJ moving forward, and they need to be a priority.
- 5. One of our communities' strengths is our diversity. What are some ways to continue to incorporate the diversity of our community.
- I see many ways to incorporate diversity. We can encourage more community wide events that bring people of all backgrounds together, we can also ensure that committees, volunteer boards, and city initiatives are open to people of all ages, backgrounds, and perspectives so decisions reflect the whole community. We also should continue to invest in our public spaces, such as the parks, trails, libraries, and gathering areas - these tend to naturally bring people together.
- 6. Communication is very important and the perception that our council is not very transparent with community members. How can you change that perception moving forward? What are some ways to improve the communication process?
- I believe leadership should be approachable. Hosting open forums, listening sessions, or informal "coffee with a council member" events would give residents the chance to share ideas and concerns directly. I also think that rather than expecting residents to always come to us, we should make an effort to attend community events, neighborhood gatherings, and school activities to hear from people where they are.

We need to make sure council agendas and meeting minutes are posted early, are easily understandable, and are readily available so that residents follow along and take an interest in what is being discussed.

Every inquiry needs thorough follow-up. It's not enough to just listen. Residents should be able to see how their input influences decisions, whether that's through public updates, summary reports, or follow-up discussions.

7. Can you explain where the money to fund our town comes from? What are your budget priorities?

Most of the money that runs our town comes from property taxes, utility payments like water and sewer bills, and state or federal funds we qualify for. Property taxes are the steady part, utilities should pay for themselves, and then we try to grab extra grants or special funds when we can. Those outside funds are never guaranteed, so we have to budget carefully.

My top priority is to keep up with our basic infrastructure — our roads, water, sewer, and drainage systems. If we don't take care of those first, everything else struggles. At the same time, I want to make sure we're supporting our small businesses because they keep our community alive. That means improving incentives for business districts, making downtown more inviting, and helping businesses access resources to grow.

I also think we need to plan ahead, not just put out fires year to year. A 3-5 year plan for projects, a savings cushion for emergencies, and communicating with the community concerning how we spend each dollar are key elements. If I'm on council, I'll work to make sure people understand where their money goes, and that every dollar is used to strengthen the town for the future.

8. What role should the community play in supporting our school district and the education of our children?

The entire community must support our schools and kids. That could be going to games and cheering on our teams, helping with fun activities for kids and families, or volunteering as a tutor to give kids a little extra help. Even small acts — showing up at an event, spending a little time with a student, or helping out at school — make a difference. When our whole community gets involved, our kids respond and our town becomes stronger
