Wayne County woman faces charges for attempted murder

A Wayne County woman faces charges after allegedly introducing Algaecide and brake cleaner chemicals into a victim's injectable medication.

Court documents state that 36-year-old Halie Spidle has been charged with attempted murder and administering harmful substances. Two bonds have been set: \$50,000 cash only for the attempted murder charge, and \$10,000 cash only for the administering harmful substances



charge.

She was taken into custody on Sept. 18. The alleged crime occurred between Aug. 1 and Sept. 18.

Spidle is due in court on Sept. 26 for a preliminary hearing.

Wayne Board of Supervisors call for closed session about New Venture

The Wayne County **Board of Supervisors** held a special meeting on Sept. 23 starting at 3 p.m. and proceeded as a regular meeting with the roll call and the Pledge of Allegiance. Following a quick discussion of agenda items, the board immediately called a closed session as permitted by code section 21.5, which allows certain discussions to be held confidentially regarding specific circumstances such as personnel issues.

The meeting was convened to discuss and

approve future plans for New Venture, discuss and approve the New Venture Interim Administrator, and discuss and approve Resolution 26-05 for removing and adding authorized signors for the New Venture Payee account and credit card.

New Venture, also known as New Venture Group Home, is a group home for individuals with mental disabilities located in Corydon. The home provides a supportive and welcoming environment for its residents. Recently, a serious incident occurred that led to a drastic change in leadership. On Sept. 18, the administrator

of New Venture, Halie Spidle, was charged with attempted murder and administering harmful substances.

The closed session lasted nearly one hour before the meeting reconvened. The board reviewed the items discussed in the closed session and voted to approve them. Lance Lange, board member made a motion to keep New Venture operating to ensure its continued success. Todd Wilson, vice chairman seconded the motion, and Chris Moore, board chairman, was the only one to object; however, the motion passed.

New Venture will continue under the co-interim administrators, Susan Moore, Wayne County Public Health Director and Mendy Middlebrook, Wayne County Community Services Director. Their immediate priorities will include assessing the current state of the group home operations, ensuring the staff maintains high standards of care, and stabilizing the administrative processes during the transition period. The interim administrators will also focus on reinforcing communication channels with residents' families and relevant stakeholders. This motion passed

with the support of all three supervisors.

The board had a quick discussion on how to move forward with removing and adding authorized signors for the payee account and credit card. Alan Wilson, county attorney, was present and advised the council to remove Spidle as an authorized signor immediately and add Moore and Middlebrook as signors. Lange made a motion after Wilson's recommendation to remove Spidle and add Moore and Middlebrook. The motion passed.

There were no public comments, and the meeting adjourned.
