Kading Properties agrees with city, on Oak Street concerns

The Corydon City Council met with a Kading Properties representative via video conference to discuss the repair plan submitted by Kading Properties for Oak Street.

Several concerns have been raised about the quality of concrete in the development, with many of the concrete panels already showing cracks within a year of being poured. The cracks appeared before the units were occupied, and there ing service. The council was very little traffic on emphasized the importhe roads.

Kading's proposal is to replace cracked panels and seal others, with a focus on ensuring the integrity of the remaining concrete. Kading maintains that there is still good concrete that remains unaffected, while admitting that this project has a lot more cracks than they usually have.

The city wants to be involved in testing and inspections, potentially using a third-party test-

tance of ensuring high standards for the quality of work, especially since the street would be publicly maintained.

The council agreed to revisit the issue in the next meeting, allowing time for further investigation and consultation with legal counsel. The consensus is that more information is needed before a final decision can be made on the project's acceptance and the proposed repairs.
