AN ORDINANCE AMENDING JEFFERSON COUNTY CODE OF ORDINANCES ADDING CHAPTER 2-35 TO PROVIDE REGULATION OF BURNING WITHIN JEFFERSON COUNTY BE IT ENACTED BY THE BOARD OF SUPERVISORS JEFFERSON COUNTY, IOWA: I. Amendment. The Jefferson County Code of Ordinances is amended by

adding Chapter 2-35, which states: Chapter 2-35 BURN ORDINANCE SECTION I. Purpose To establish requirements for certain types of controlled burns within Jefferson County. To establish notification requirements as a courtesy to avoid the local fire departments and emergency personnel from being called out mistakenly at the report of a controlled burn. Section VII. Exemptions
Section VII. Exemptions
This ordinance shall apply to all unincorporated lands and areas without open burning ordinances that lie within the boundaries of Jefferson County, lowa. This ordinance shall not supersede any city or municipal burning ordinances.
The following are exempt from this ordinance:
1. Grills or Smokers – This ordinance shall not apply to outdoor grills or smokers. Grills and smokers can be wood or charcoal burning, propane or natural gas burning, or electric.
2. Outdoor Fireplaces – This ordinance shall not apply to outdoor fireplaces. Outdoor fireplaces. Color Fireplaces. Color Fireplaces. Color Fireplaces. Color Fireplaces. Burn Barrels – This ordinance shall not apply to any burn barrels properly outfitted with spark-arresting screen/device used for the purpose of burning household trash, landscape waste or yard trimmings. Burn barrels must be all east fifteen (15) feet away from structures or any other combustible material.
Other Allowable Exemptions – Other exemptions as identified in lowa Code 567-232.
SECTION VII. Penalty for Nancompliance
