2. PUBLIC COMMENT

1. PH 2025-48. Mayor Bentz announced this is the time and place for a public hearing on the matter of the proposed Ordinance 2227 vacating a portion of SW Ordinance Road public right-of-way shown as Seventeenth Street, Addition to Ankeny, containing 0.20 acres (+/-). Notice of this hearing was published in the Des Moines Register on the 23rd day of May, 2025.
Eric Jensen, Director of Community Development, reported that the city has initiated a public hearing on the SW Ordinance Road right-of-way, between SW Cherry Street and one property east of SW Walnut Street. The subject of the hearing is originally deeded to the City with the approval of Thomas Addition to Ankeny in 1896. The final plat names this street Section Seventh Street. From aerial photos taken in the 1930's, it appears that Seventh Street did exist. Then, by the 1950's and 1960's, the aerial photos show SW Ordinance Road in its current alignment. City staff have determined that there is no public right-of-way in this section of SW Ordinance Road. The excess right-of-way to the east and further west of this section has not been vacated. It is believed that this portion of right-of-way was intended to be vacated in 1962 with the passing of Ordinance 2227. However, there is no record of deeds conveying to adjacent owners.

Mayor Bentz asked for any public comment regarding the proposed annexation. Hearing no comments, Council Member Stearns moved, Graber seconded, to consider public hearing 2025-48. Ayes: 4
