2021, located in Madison County, Iowa, to-wit:

Community Center Mayor Bryan Arzani presided over and called the meeting to order at 6:00 p.m. Ancel Kennedy, Matt Masters, Julie McMichael were present, and Lyndsay Cannoy and Jason Phillips were absent. Fire Chief Terry Stills and Public Works Director Ronnie Hults were also present. No one from the public was present to speak. Arzani asked for a motion to approve the Agenda. McMichael/Masters motioned. All Aves. motion carried. Arzani and the council acknowledged the Sheriff's report and the Emergency Management Director's report. Terry Stills presented the Fire & Rescue Report with 7 fire calls and 15 EMS calls. He also stated the Truro Fire Association purchased a tanker from the City of St. Mary's and gave it to the City of Truro. Fire & Rescue also received a \$10,000 grant from Prairie Meadows and is being used to purchase needed equipment. Chief Stills also said they received an anonymous donation of a heating/cooling unit for the Fire & Rescue meeting room. Heidi Burhans asked to revisit a previous City Council approved culvert purchase that had never been followed through for her property. The City would purchase, and the homeowner would be responsible for the cost of installation. No action needed since previously approved. Public Works Director Ronnie Hults said he would make those arrangements. Tim Palmer did a Solar Power presentation, specifically for the city lagoons. More information is needed, still under discussion. Public Works Director Hults stated the June and July storms have caused damage to the lagoons and they need repair, replacement, and need updated systems. He also stated he will be getting ready for "back to school"

with painting sidewalk crossings etc. Mayor Arzani reported we had an audit and the recommendations from the Auditor of State. Resolution #2026-2 Credit Card Policy was presented. A motion was made to approve Resolution #2026-2 Credit Card Policy with the addition of verbiage of the "appropriate documentation to be provided for each purchase", by Kennedy/McMichael. All Ayes, motion carried. Resolution #2026-3 Wages was presented. A motion was to approve Resolution #2026-3 Wages by Masters/McMichael. All Ayes, motion carried.
