The Board of Directors of the Algona
Community School District, in the County
of Kossuth, State of Iowa, met for a pub-
lic hearing in the Boardroom, Performing
Arts Center, 600 S. Hale Street, Algona,
Iowa at 5:30pm on the above date.
PUBLIC BUDGET HEARING #2
The hearing opened at 5:30pm.
Superintendent Carter reviewed the
notice that was published on March 6,

2025, and again on April 3, 2025, for the
school district. The \$10.02 rate per thou-
sand was explained. This is an average
of the three rates for the patrons in the
Algona School District, former Lu Verne
district residents and former Titonka
district residents. Even though the tax
notices show that the tax rate would be
a 13.45% increase for residential prop-
erty owners, that is not the case since
the assessed value of properties will not
change in this odd year as the example
shows. The rollback percentage rate is
also increasing by 2%. In net, the rate
is increasing by only 1.45% per thou-
sand or 8 cents. The increase is due to
the formula changes in reorganization
incentives. The budget sets the maxi-
mums that can be set in each category.
The budget hearing ended at 5:33pm.
