

Update on Kossuth County Scam Case

On February 27th, 2025, the Kossuth County Sheriff's Office released a report that an individual by the name of Eddie Benitez, age 33 of Miami Florida, had been arrested for Theft in the First Degree regarding a grandparent scam that occurred within Kossuth County.

On April 15th, 2025, Kossuth County Deputies took custody of a second suspect in this case. A nationwide warrant had been issued

Carlos Garrido Guzman, age 29 of Homestead, Florida.

Guzman was arrested on April 11th in Miami, Florida and extradited back to Kossuth County on April 15th for:

Theft in the First Degree, Class C Felony and is being held in the Kossuth County Jail on a \$75,000 cash bond. Both Benitez and Guzman are also being held on other warrants from agencies that also had victims of scams. All persons arrested are presumed innocent until proven or found guilty in a court of law.

The Kossuth County Sheriff's Office would like to remind all citizens to use extreme caution

if you are contacted by phone or through social media regarding any individual or persons identifying as a business or government agency that claims you will need to pay money or purchase gift cards. The scammers will use numerous scenarios to try and convince you that your money is needed to help someone in trouble or in need. Do not provide any of your personal information and contact your local law enforcement so they can confirm this is a potential scam.


rock were added. 50 Years Ago
