or destroyed, the insurance company will help cover the costs of repairs or rebuilding. Floods, wear and tear, and earthquakes are excluded perils.

Coverage B - Other Structures: Beyond your primary dwelling, this coverage extends to other structures on your property, such as detached garages, sheds, fences, or guest houses. It provides financial protection if these structures are damaged or destroyed due to covered perils.



At this time of the session, it becomes very busy fitting in meetings to present bills that may be outstanding yet. Two such bills, SSB 1234 and HF 1007, were scheduled. SSB 1234 is a bill that establishes a retirement savings plan trust to provide a retirement savings plan for all Iowans. The bill provides for appropriations and implementation provisions. In subcommittee the support was positive, but it will need some work yet.

Coverage C - Personal Property

This type of coverage safeguards your belongings inside your home, including furniture, clothing, electronics, and appliances. Coverage E - Personal Liability: Liability coverage protects you financially if someone is injured on your property or if you accidentally damage someone else’s property. It covers legal expenses, medical bills, and compensation for the injured party up to the limits specified in your policy. It would

File 639. House File 639 is a bill to ban the use of eminent domain for a private company, seeking private profits. The purpose of this action is to finally address the issue of the use of eminent domain and how it is to be applied in the state of Iowa. This is an issue of property rights and the constitutionality of using eminent domain to take a person’s private property.

While the “Taking Clause” under the 5th Amendment clearly says “taken for public use,” the small print is the term “public use” and court interpretations of what that definition is. The taking of property is constitutional if the public has a right to employ it, to use
