Swartzrock Implement Co. celebrates 75th Anniversary

Steve Swartzrock tells the story of his father Harold, a man with a fifth-grade education who ran a Shell service station along Highway 14 in Charles City back in 1950. Both he and his wife Darlene, a telephone operator at Bell in town, had lived through the Great Depression (1929-39) and were getting by, but were far from wealthy.

"A guy came in one day and asked my dad if he wanted to be a farm equipment dealer and sell Minneapolis-Moline? My dad said he had always dreamed of being a farm equipment dealer, but didn't have any money. He had maybe \$150. The guy said I think we can make that work," stated Steve. "Everyone in Floyd County said 'Harold, you guys are going to go broke!' My dad laughed and said 'Hell, we were already broke from the start.""

He and Darlene founded Swartzrock Implement Co., and 75 years later it continues to be a thriving family business under their son Steve and his sons Ben and Dan. Recently the Charles City Chamber Ambassadors stopped by 2192 Old Highway Road to congratulate the Swartzrock family and help commemorate the milestone anniversary.

"My dad and my mom worked from 7 a.m. to 11 p.m. every day, and had one mechanic when they started out," Steve said. "Mom was the bookkeeper, and if she was off 5 cents she worked hours to figure it out. That generation went through the Depression and never had anything. They worked

"When I was two weeks old my mom threw me in a crib on the showroom floor, and I never left," he remarked. "I have literally worked here my entire life."

He did attend NIACC and earned a degree in Mechanical and Ag Engineering. Ben was a mechanic/ag engineer for John Deere for five years before joining the family business, while Dan did the combine wheat run from Texas to Canada prior to coming back home to work.

Steve said timing was everything for their business, as his father invested to expand and build the current facilities in 1972, just before the big farm boom in 1973-74.

"The crash hit in 1980, and all the implement dealers who built big new buildings in the late 70's went broke," explained Steve. "At one time there were 12 implement dealers in Floyd County, now there are two - us and Red Power in Greene."

Asked about the biggest change in the industry over three-quarters of a century, aside from farm equipment getting larger and more computerized, Steve said it has been the Internet.

"Now the Internet is your best friend or your worst enemy," he remarked. "I sell stuff now to Kansas, North Dakota, South Dakota, Montana, up in Canada, Mexico and even over in Europe. We would never survive on Floyd County alone, or even northeast Iowa. The Internet is a big thing for us."

He admitted the current tariff situation is making it "very hard to get stuff across the borders right now," but "I think the future looks very good, because of what is happening in our industry. Deere and Case are consolidating dealers. We have 16 employees and they have 1,200 employees. To them, farmers are just a number, and farmers don't like that. I think there is a market

Campbell's Co. says sales rise as more Americans cook meals at home

The Campbell's Co. said Monday it saw stronger sales of broth and condensed soup in its latest quarter as more Americans cooked their meals at home.

"Consumers continue to cook at home and focus their spending on products that help them stretch their food budgets, and they're increasingly intentional about their discretionary snack purchases," Campbell's President and CEO Mick Beekhuizen said during a conference call with investors. Beekhuizen said Campbell's saw the highest level of meals cooked at home since early 2020 in its fiscal third quarter, which ended April 27. Campbell's noted sales of its broths rose 15% during the quarter while sales of its Rao's pasta

sauces were up 2%. But Campbell's said sales of its snacks, including Goldfish crackers and Cape Cod potato chips, fell 4% during the quar-

ter. Other big companies, including McDonald's, have also noted that Americans are increasingly eating at home as uncertainty over the economy grows. Grocery prices have also moderated. In 2024, prices for food eaten at home rose 1.2%, while prices for food away from home rose 4.1%, according to the U.S. Department of Agriculture. Snack makers like Pepsi-Co, which makes Frito Lay chips, and General Mills, which makes Bugles chips and Golden Grahams, have also noted lower demand for snacks in recent quarters.
