Jerry Dencklau of rural Thor was welding just outside of his garage on the evening of April 14 when a loud deafening sound like a roaring train accompanied by the snapping and splintering of wood, startled

At first I thought just a small piece broke off of the barn. "It was around six or "I was in the garage and 6:30 p.m. The sky was full of dark clouds. We didn't get any rain or hail from the fast-moving storm like some other areas got, but we sure had the powerful winds that came with it," Dencklau said.

"You could just hear the loud snapping and cracking of wood inside the barn and of course the roar of the wind," Dencklau said.

Fortunately, Dencklau didn't have anything of value inside the old white "The barn is at least 100

years old or more. It was being supported by bolts to help strengthen it. I knew it would come down sometime, but I didn't expect it to happen this year," Dencklau said. "Not just

Kossuth County deputies arrest scammers

On Feb. 24, the Kossuth County Sheriff's Office took a report of a subject from the Burt area that was the victim of a scam.

The Sheriff's Office and Algona Police Department put out information regarding a grandparent scam where the victim is told over the phone that a grandchild is in some type of trouble and needs bond money to be released from jail.

The caller then scams the victim into believing that the only way they can help their grandchild is by paying a cash bond to a bondsman that will stop by the victim's house to collect the

In the Burt case, the victim was told a bond amount of \$10,000 was needed. A person came to the residence and collected the cash. Deputies collected video evidence and statements and worked with local and state agencies in Iowa.

With assistance from the Iowa Division of Criminal Investigation, Kossuth County deputies were able to secure GPS tracking warrants on two suspects in the Burt Case.

On February 27th, 2025, the Kossuth County Sheriff's Office released a report that an individual by the name of Eddie Benitez, age 33 of Miami, FL, had been arrested for Theft in the First Degree regarding a grandparent scam that occurred in Kossuth

On April 16, 2025, Kossuth County Deputies took custody of a second suspect in the case. A nationwide warrant was issued for Carlos Garrido Guzman, age 29 of Homestead FL. Guzman was arrested on April 11th in Miami, FL and extradited back to Kossuth County on April 16th for Theft in the First Degree, a class C felony and is being held in the Kossuth County Jail on \$75,000

Both Benitez and Guzman are also being held on other warrants from agencies that also had victims of the scams. All persons arrested are presumed innocent until proven or found guilty in a court of law.

The Kossuth County Sheriff's Office would like to remind all citizens to use extreme caution if you are contacted by phone or through social media regarding an individual or persons identifying as a business or government agency that claims you will need to pay money or purchase gift cards.

The scammers will use numerous scenarios to try and convince you that your money is needed to help someone in trouble or in need. Do not provide any of your personal information and contact your local law enforcement so they can confirm this a

Humboldt City Council adds police officer, approve budget

Humboldt's police department continues to get closer to full force after the Humboldt City Council approved the hiring of another officer at their regular meeting on Monday night, April 21.

The council approved hiring Stephen Hale as a full-time officer. Hale comes from Lake City, where he has been the police chief. He has four years of experience in law enforcement. Hale was sworn in by Humboldt Mayor Dan Scholl.

Hale, who will begin in Humboldt on May 7, will be paid a non-probationary rate of \$30.98 per hour.

"I've done all the background checks and everything that needs to take place for him to come up here," Humboldt Police Chief Jacob Miller said.

The department now has four full-time officers, not including

Miller, along with one part-time officer. Miller will work to add another full-time officer to the

Hale and his girlfriend, Courtney Matthews, a Humboldt native, have a combined five children. They were in attendance to watch him get sworn in Monday night.

"I grew up in Auburn, south-Army when I was 17-yearsold," Hale said. "I was in the Army for 12 years and joined law enforcement four years ago when I was hired on at Lake

"Courtney and I have bought a house in Humboldt and have moved up here. Our oldest child is 12 and our youngest is 7 so we have a fun, active household," Hale said.

After a public hearing with no objectors, the council approved the budget for fiscal year 2025-

Total expenditures are estimated to be \$11,236,864 with total revenues anticipated to be \$10,973,874 with a property tax rate of \$15.8934 per \$1,000 of assessed valuation. It is down slightly from the current rate of \$16.1869 for the 2024-25 bud-

"We had a good legislative meeting with representative Mark Thompson in Clarion last Friday. Quite a few other

city officials were able to join us. There are two new property tax bills being introduced based off of feedback from the first round," Bockelmann said. "The 2 percent cap on growth has now been changed to the CPI (Consumer Price Index), but that's still basically two percent, so that change is not over-

"And TIF (Tax Incremental Financing) is still in a flux because of the way the bill is written. That is a major concern for myself and Alissa (O'Connor, executive director of the Partnership for Economic Growth of Humboldt County) because TIF has provided a good chunk of our development funding over the last 20 years," Bockelmann said.

"In talking to representative Thompson, it sounds like the lawmakers are going to pump the brakes and continue on to

the next session while they take more time to look at the tax overhaul. It's the most substantial change in 50 years," Bockelmann said.

Councilman Joel Goodell asked Bockelmann if the proposed changes would affect past development projects in Humboldt.

"I think it has a good chance to impact past projects. They are changing the levies for the schools, cities and counties, which would decrease our abilities to capture TIF for existing projects, unless they write in an

exemption. As of today, that's not in there," Bockelmann said. One of our major concerns is businesses that we've pledged

rebates to, I don't know if we would be able to fulfill the debt service on projects.

"I don't know how we would

make those payments if the levies are cut in half or more," Bockelmann said.

Bockelmann reported Blacktop Service Company will begin its road paving projects. Several blocks of 3rd Street South and 12th Street North will be included in the paving.
