Iowa's Low-Income Telephone & Broadband Assistance Programs

Programs are available in Iowa offering discounted phone and Broadband service if a subscriber or member of the subscriber's household meets certain qualifying criteria. This program is also called "Lifeline".

An application must be completed along with proof of participation in one of the qualifying programs and sent to Winnebago Cooperative Telecom Association.

The Low-Income program offers discounts of up to \$9.25 per month depending on the rate of your local phone company. See Winnebago Cooperative Telecom Association for an application form.

Qualifying Criteria for Low-Income Program

An individual is eligible if he or she participates in one of the following programs:

- Federal Public Housing Assistance
- · Supplemental Nutrition Assistance Program (SNAP)
- Supplemental Security Income (SSI)
- Tribal Programs
- Veterans & Survivors Pension Benefit

In addition, a consumer may be eligible if his or her household income is at or below 135% of the federal poverty guidelines. You may only receive low-income assistance from one wireline or wireless telephone, or one broadband service provider per household. 
