# Services held August 8 for Henry "Hank" Hellinga, 92

Funeral services for Henry "Hank" Hellinga, 92, were held Friday, August 8 at St. Matthew Lutheran Church in Worthington, MN with Pastor Timothy Nappe officiating. Burial was in Ochevedan Township Cemetery with Benson Funeral Home, Worthington, MN in charge of arrangements. He died August 3, 2025.

Henry James Hellinga was born April 15, 1933 on a farm between Ocheyedan and Harris. "Hank's" family lived on several different farms in the area until buying the current Hellinga family farm in 1943. Hank's family raised purebred Shorthorn cattle and Spotted-Poland hogs, along with other typical livestock and crops.

Hank attended Harris High School, graduating in 1951. He enrolled in classes at Iowa State University in the fall of 1951. On October 8, 1955, Donna Damge and Hank were mar-

Hank worked on the family farm and for other farmers in the area. In the fall of 1958, Hank and Donna moved to Ames where he resumed his education at ISU. He ultimately received a degree in mechanical engineering.

After college, Hank received a job offer from Torrington Company and relocated the family to Connecticut. Later he was transferred to a plant in South Bend, IN. Hank, Donna and family enjoyed camping. Besides camping and travel Hank had pastimes that in-

cluded woodworking, modelrailroading, golfing and bowling. He was involved in many civic activities. Hank and Donna bought a lumber/hardware store and managed that for several years until Hank retired. In 2010, after 55 years of marriage, Donna passed away

suddenly. Shortly after her death, Hank received a phone call from Maureen, whose husband and also just died unexpectedly. Hank and Maureen had dated in high school. There was still a spark there and they decided to marry June 4, 2011.

Visiting family and attending milestones in their shared children and grandchildren's lives, were high points of their time together. After living in Ochevedan for over a decade, they moved to The Meadows in Worthington, MN in early January 2025.
