

My name is Kevin Alons. I'm a patriot, a conservative, and a Republican. It is my honor to serve as an Iowa State Senator. As I've seen for years, Iowa's government is at a crossroads. People in power have a decision to make. The question is

On one side: "The ernment should allow nent Domain for private gain." On our side: "The government must protect Iowans' property rights."

This seems like an easy call. After all, in the Legislature where I serve, your elected representatives Republican and Democrat alike - voted overwhelmingly to protect property rights, even under tremendous pressure from big business and big politics. As an Iowan, I was encouraged to see the Legislature finally bring up the elephant in the room: whether the government will allow Summit Carbon Solutions to invade and take your land for their own private interests. We - your representatives - voted for you. Now, the question is in the hands of Governor Kim Reynolds.

Let's rewind the clock to last year. The Iowa Utilities Commission – people no one voted for – said "maybe" to that critical question. That government agency decided that if South Dakota and other states agreed to Summit's pipeline, then the company could use Eminent Domain to take Iowans' land. It is unusual and unthinkable that under Iowa law, three unelected people could actually give a private company the right to take my constituents' land for some novel and unusual project. While it's a good thing the Commission put some restrictions on this land grab, those weren't nearly enough to protect

This year the Iowa Legislature passed a simple bill that puts traditional Eminent Domain rules back in place for these new, unusual, and dangerous things that Summit wants. Let's be clear: all we want is a return to the free market. Specifically, when companies want pipelines to carry poisonous liquefied gas through so many farms and towns in Iowa - which is Summit's goal - they should do so through voluntary easements, and not through the power of the government. 30% of Iowa's ethanol plants have not signed up, how could it be acceptable to force private citizens to do so?

That's the question now on Governor Reynolds' desk. I and my colleagues - on behalf of so many Iowans whose lives and livelihoods are at risk - have one message: Let's Get This Done. Governor Reynolds has been a defender of individual rights and of our values since the day she took office. Protecting property rights can be her legacy and it should be.

And yet - as a military officer, I am well aware that in a conflict, the other side gets a vote too. So, let me address that and cut through the junk. As some members of my own party came out swinging against House File 639, the "No Eminent Domain for Private Gain" bill, it nonetheless passed the Iowa Legislature in a once-in-a-generation bipartisan way. This is because Iowans want a return to the Constitu-

Opponents of this common sense legislation argued that "Iowa will be sued for half a billion dollars" if this becomes law. They said this utilities commission ruling is a "contract" between Iowa and the mega-million dollar company that wants our land - even though the conditions of the permit simply can't be met. The argument is that Summit invested money with a guarantee that the pipeline was approved, so any legislative action represents a "breach of contract".

When you consider the timeline of the unexecuted pipeline project, the pursuit of and payment for voluntary easements, and the issuance of the conditional permit, this argument is revealed for the deception it is. Most of these speculative payments were made long before June 2024, when the IUC conditional permit was issued - to imply that the state could be liable for actions taken by a company before any approval was granted is laughable or an admission of "quid pro quo".

Regardless, standing for the constitutional rights of my constituents is worth the risk and I welcome the fight. We must respond to the abuses that the government and Summit has put upon affected landowners. It is a fight we must fight and will win.

Governor Reynolds has been a defender of property and individual rights since her first day in office. I am honored to be one of so many state legislators who put House File 639 on her desk. Not only should she sign it, she should sign it with real pride – her signature on this bill means a "win" for landowners, and a permanent restriction on government abuses of power over people.

After all, if the government can take your land, it can take everything else from you, too. So let's fix this. Let this signature be the crowning achievement of Governor Reynolds' legacy.
