Trump Accuses Zelensky Of Harming **Peace Talks**

Ukraine's Vladimir Zelensky could lose the entirety of his country if he continues stalling talks with Russia, U.S. President Donald Trump warned in a post on Truth Social on Wednesday. Zelensky had publicly announced that Kiev will not even discuss officially recognizing the Crimean Peninsula as Russian, a key tenet of a Washington-backed peace proposal which it was to present at a meeting with officials the country's European backers on Wednesday. Following the rebuttal the top members of the U.S. delegation withdrew from the planned talks, leading to the meeting being "downgraded" at the last minute. "This statement is very harmful to the Peace Negotiations with Russia in that Crimea was lost years ago," Trump wrote, accusing the Ukrainian leader of prolonging the conflict. Crimea's predominantly ethnic-Russian population voted to join Russia in a referendum in 2014, following a Western-backed armed coup in Kiev.

New Mexico Judge Resigns After Alleged TdA Member Arrested At His Home

A New Mexico judge resigned from the bench after an alleged Tren de Aragua gang member was arrested at his home. Doña Ana County Magistrate Judge Joel Cano's resignation letter is dated March 3, but a spokesman for the Administrative Office of the Courts (AOC) told Fox News Digital it was not received by the Supreme Court and 3rd Judicial District Court until March 31. Back in January, Homeland Security Investigations Las Cruces began looking into Venezuelan native Cristhian Ortega-Lopez, "an illegal alien from Venezuela and a suspected member of a criminal gang" who was "residing with other illegal aliens" and "in possession of firearms," according to court documents obtained by Fox News Digital. On Feb. 28, two search warrants were executed at a home investiga-

RFK Jr's FDA Announces It's Stripping Out 'Toxic Soup' Of Food Dyes From US Supply In Massive Shakeup

FDA Commissioner Dr. Marty Makary announced the agency will phase out the use of eight artificial food dyes in America's food supply within the next two years. The massive shakeup will free children from the "toxic soup" that makes up much of America's food supply, Dr. Makary said. The Trump administration will set a plan for food companies to follow in order to adequately phase out the use of Red 40, Yellow 5, Yellow 6, Blue 1, Blue 2, and Green 3 by the end of 2026 and start using natural alternatives, which the FDA will approve or deny first. "For companies that are currently using petroleum based red dye, try watermelon juice or beet juice," Makary said, lifting small bottles of juice off his podium. "For companies currently combining petroleum-based yellow chemical and red dyes together, try carrot juice."

Steam Spotted Billowing From Massive U.S. Volcano As American City Braces For **Imminent Eruption**

A massive volcano in Alaska is now steaming from its summit crater, signaling more signs of unrest. Scientists have been keeping a close eye on Mount Spurr, a 11,000-foot-tall volcano that sits just 81 miles from the city of Anchorage, over the past few months due to growing signs it is ready to blow. In the Alaska Volcano Observatory's (AVO) latest update, scientists said webcam images captured over the weekend showed "continued steaming from the summit crater." "This type of steaming is typical for Mount Spurr during this current period of unrest," their statement reads. If Mount Spurr does blow, the event "would be explosive," Matt Haney, scientist-in-charge at the AVO, previously told DailyMail.com.

young staffers, according to the Wall Street Journal. Top Trump Officials File Charges Against Illegal Immigrant After Fox News Exposes Early Release Plans

The Trump administration is filing federal charges after hearing that an illegal immigrant convicted of manslaughter is set to be released over six years early by the California state government. Oscar Eduardo Ortega-Anguiano was driving drunk, high, and speeding at nearly 100mph on the 405 freeway in Orange County in November 2021, when he crashed into a car being driven by a young couple, 19-yearolds Anya Varfolomeev and Nicholay Osokin, which killed them both as they burned alive. In spring 2022, he was convicted of two counts of gross vehicular manslaughter while intoxicated. Fox News reported on Wednesday morning that Ortega-Anguiano will be released by California state government on July 19 after serving just 3.5 years of his 10-year sentence, and the families of the victims were informed of the early release on Easter Sunday.
