Motion by Teel and seconded by Morton to approve the agenda. Roll call vote: Ayes: all. Motion carried.

Motion by Davis and seconded by Morton to approve the consent agenda which included: minutes as presented for May 5 and 14, 2025, bills as presented, May 2025 financial report. Roll call vote: Ayes: all. Motion carried.

Gov. Reynolds Signs Law Cutting Unemployment

Reynolds said.

Iowa Public Radio id reporting that Iowa businesses will get an estimated \$1.2 billion tax cut over the next five years under a new law signed Thursday, June 5, by Gov. Kim Reynolds.

Reynolds said cutting unemployment insurance taxes was one of her top priorities for this legislative session.

The Governor said the state's unemployment trust fund is the 9th largest in the country, even though Iowa is 32nd in population, and the state has needlessly over-collected unemployment taxes from businesses.

"I truly do believe that it will make a difference in making us more competitive as a state, and for employers across the state to give back to their community, their busiThe new law — which takes effect July 1 - lowers the top unemployment tax rate from 9% to 5.4%, decreases the number of tax tables, and cuts the amount of wages that are taxed by about half. That is expected to reduce payments into

the unemployment trust fund by nearly \$1.2 billion over the next five years, according to the nonpartisan Legislative Services Agency (LSA). The new law states that employers should use

any savings from the tax cuts to pay for employee salaries or benefits, or to use as an alternative to unemployment benefits during periods of seasonal unemployment. But it doesn't require businesses to use the savings for

those purposes.

Democrats in the Iowa Legislature opposed the bill.

"While Iowa families struggle and Iowa's economy ranks dead last, Gov. Reynolds and Republican lawmakers are handing out a \$1 billion tax break to big corporations, paid for by raiding funds meant for laidoff workers," Rep. Dan Gosa, D-Davenport, said in a statement Thursday.

"In 2022, Iowa Republicans slashed unemployment from 26 weeks to 16," he said. "Now they're handing out tax breaks to corporations that lay off workers and ship jobs overseas. Iowa workers shouldn't be footing the bill for corporate tax breaks."

Monona County Board Of Supervisors Meeting

The Monona County Board of Supervisors met in regular session at 8:30 a.m. on Tuesday, May 27, in the boardroom of the courthouse in Onawa, Monona County, Iowa with Chairman Fox presiding. Other Supervisors present were Tom Brouillette and Vince Phillips, who left the meeting at 11:45 a.m. Also present was Auditor Peggy A. Rolph.

The Supervisors voted to approve the agenda.

Abby Riesberg, Treasurer was present for approval of an additional camera in the Motor Vehicle window. The Supervisors voted to deny Treasurer Riesberg request of an additional camera in the Motor Vehicle window facing the hallway, since there are already cameras in the courthouse for security purposes.

Present, along with the Supervisors and Auditor, for the Elected Official / Director Meeting, were Abby Riesberg, Treasurer; Jim Wigton, IT Director; Sandy Bubke, Zoning/Environmental Health; Kelly Parsley, Recorder; Charles Bechtold, Secondary Roads Engineer; and Wray Wright. Absent were Haley Bryan, County Attorney; Kevin Ewing, Sheriff; Tim Peters, Assessor; Patrick Prorok, EMA Director; Josh Schaben; Conservation Director; and Mark Witzel, Veteran Affairs Director. The Supervisors adopted Resolution No. SR 25-15: hiring Darin Jacobson to fill the Full-time Operator III position at a Start rate of \$24.01 per hour (90% of \$26.68), with wages and benefits in accordance with the current Union Contract and County Policies. Permanent seniority will begin accruing upon successful completion of a background check, pre-employment physical and drug screening.

The Supervisors voted to approve six-month wage adjustment for Jeffrey Pithan. Jeffery will be going from \$23.01 per hour to \$24.28 per hour per Union Contract.

Discussion items were dust control, FEMA, pavement program and gravel roads. No action was taken.

Peggy Rolph, Auditor was present to open quotes for election trailer, the prior election trailer was totaled by the hailstorm in June 2024. Marx Trailer quote was \$9,985 for a 101 x 20 H&H enclosed cargo trailer with tandem 3,500# axles, production lead time is approximately six weeks. County Trailers quote was \$11,369.44 for an Arrow model 820TA 8.5x20 Alpha Series with 3,500# spring tandem axles. OC Trailers & RV's, Inc. quote was \$9,075 for a

Fund balance stood at \$1.89 billion. In 2024, according to the LSA, the state paid out \$316 million in unemployment benefits. LSA estimated 102" wide x 20' American Hauler Arrow trailer with tandem 3,500# spring axles. The Bids will be reviewed, no action taken.

The Supervisors acknowledged the receipt of withdrawal of resignation letter from Jim Wigton, IT Director and the receipt of Certification of Tax Levy for Brucellosis and Tuberculosis Eradication Funds.

The meeting adjourned at 12:50 p.m.
