## **Importance of Measles Vaccination Amid** Rising Concerns and Cases Nationwide

(SBA) - UnityPoint Health-Sioux City and Siouxland District Health are encouraging community members to stay informed and protected against measles as cases continue to rise in parts of the country. Both organizations remain committed to supporting families and patients through education, access to vaccines and trusted medical guid-

"Vaccines remain one of the most important tools we have to prevent serious illness," said John Jones, MD, chief medical officer at UnityPoint Health - Sioux City. "We understand that people may feel overwhelmed or hesitant, but our goal is to be a supportive partner to our patients and their families. The MMR vaccine is safe, effective and provides lifelong protection for most people."

Measles is a highly contagious virus that spreads easily through coughing, sneezing, or even breathing the same air as someone who is infected. The virus can remain active in the air or on surfaces for up to two hours, increasing the risk of exposure in public spaces.

"Because measles spreads so easily, vaccination is the best line of defense," said Tyler Brock, deputy director at Siouxland District Health. "A full series of the MMR vaccine is 97% effective. For young children especially, staying up to date on routine vaccines through wellchild visits is essential."

While vaccine fatigue and hesitancy are real concerns, local health leaders are urging the community to take action now—both for individual protection and community health.

"Measles is preventable," added Dr. Jones. "By making sure you and your family are vaccinated, you're helping protect not only yourselves but also those who are more vulnerable—like infants or individuals with weakened immune systems."

Those who need to schedule vaccinations or have questions about their immunization status should contact their primary care provider. Patients are encouraged to call ahead before visiting a clinic or urgent care to ensure they are directed to the appropriate care setting.

### **Immunization Requirements Announced** for SBL-CSD 2025-2026 Registration

(SBA) - As registration for the 2025-2026 school year at Sergeant Bluff-Luton Community Schools continues, immunizations are required for students entering primary school, 7th grade, and 12th grade.

Students entering primary school after age 4 must have 5 doses of DTaP, 4 doses of Polio, 2 doses of Varicella, 2 doses of MMR, and 3 doses of Hepatitis B. For preschool requirements, please contact the

To enter 7th grade, students need 1 dose of Tdap and 1 dose of Meningococcal. For 12th grade, students must have 2 doses of Meningococcal.

change means higher property tax- million in K-12 school funding es. For example, a house valued between \$400,000 and \$500,000 will see a significant increase in property taxes under the new sys-

Assuming a house valued at \$450,000:

Under the current system, the rollback rate is 47.43%, making the taxable value \$213,435. With a GO bond rate of \$4.05 per \$1,000 amounts to \$864.11

In contrast, the proposed system calculates property taxes based on the full assessed value of \$450,000. With a GO bond rate of \$2.85 per \$1,000 of assessed value, the property tax would be \$1.282.50.

Sen. Dan Dawson and Rep. Bobby Kaufmann, chairs of the Senate and House Ways and Means committees, respectively, stated that the updated property tax proposal includes measures to provide small communities with budgeting certainty and increases the homestead property tax exemption benefit from \$25,000 to

Despite these changes, local government representatives have raised concerns about the impact on tax increment financing (TIF) revenues and the shift of \$426

from property taxes to the state. Critics argue that the legislation could threaten local governments' ability to provide essential services. They worry that the cap on property tax levy growth and the elimination of the rollback system will disproportionately affect smaller communities and those with less robust economic growth. Additionally, the shift of school of taxable value, the property tax funding from property taxes to the state could create budgetary uncertainties for local school dis-

> Rep. Kaufmann acknowledged the public's concerns about rising property taxes, stating that the goal is to provide real relief to Iowans and make the state more competitive. Senate President Amy Sinclair emphasized the importance of getting the legislation right, even if it means delaying its

> While the proposed bill aims to bring predictability and transparency to taxpayers, the shift to taxing the full assessed value of properties will result in higher property taxes for homeowners. The legislation is expected to undergo further scrutiny and feedback before its intended passage during the 2025 legislative ses-
