Understanding their influence as role models. NHS students forge connections with younger SBL students. They visit primary and elementary classrooms to read with students, play at recess, and assist in events like Field Day. Each October, they host Haunted Hallways, where they transform the high school hallways into spooky spaces and invite students in second through seventh grade to walk through them. "Showing strong character is an important part of our organization. We know younger kids look up to us," says senior Brooke Hanson. "I remember when I was at the primary school and the high school students visited our classrooms. Now it's fun to be the high school student who visits the younger grades."

They also host activities for their peers. They help to organize the annual Powderpuff game during Homecoming Week, where the high school girls play flag football. In February, NHS hosts the annual Buffball tournament, where teams of high school boys play volleyball matches until one team is crowned the champion. NHS also planned a winter Twirp dance for high school students this year.

This year, the chapter celebrated the achievement of Claire Husen, who made school history as Sergeant Bluff Luton's first recipient of a National Honor Society scholarship. Thousands of qualified high school seniors from across the country apply for this prestigious award and scholarship each year. Claire, daughter of Troy and Renee Husen, was awarded a \$3200 scholarship for this honor.

The SBL NHS induction ceremony, held in early April, welcomed 18 new members. Students are eligible to apply for NHS during their sophomore and junior years. They apply by creating a resume that lists their academic achievements, extracurricular activities, leadership experience, and volunteer activities. They also ask two teachers to submit letters of recommendation on their behalf, and they write an essay that addresses the four pillars of National Honor Society: scholarship, leadership, character, and service. Finally, each applicant is interviewed by a panel of teachers and multiple panels of current NHS students.

Each spring, the chapter elects new officers to lead the group the following school year. Outgoing officers from this school year include Claire Husen (president), Brooke Hanson (vice-president), Kendra Berglund (secretary), Tate Loffswald (treasurer), and Cora Eckhoff (historian). Incoming officers, elected to lead during the 2025-2026 school year include Parker Kilburn (president), Ayla Sieperda (vice-president), Bjella Bockenstedt (secretary), Izzy Schaap (treasurer), and Makenna Nelson (historian). The teacher advisor for National Honor Society is Ashley Hansen.
