Sioux Center developing its electrical plan

Construction on new facility to begin spring 2026

Sioux Center Municipal Utilities is making progress toward adding more than 11 megawatts of local standby electric generation, improving the community's long-term energy secu-

The Sioux Center City Council recently reviewed construction concept for the local generation facility. It is to be built just south of Sioux Center's north electric substation and water tower. Work on the building will start in spring 2026. It will house four Caterpillar generators, scheduled to arrive in

"Local generation is one way we can strategically invest in reliability and rate stability in Sioux Center as we see the energy market continue to fluctuate with factors ranging from weather to politics," said Utilities manager Murray

The generation is a partnership between Sioux Center and the city's wholesale power supplier, Missouri River Energy Services, and the plan is to operate at the rare times when electricity is limited or very expensive on the entire grid. This will reduce the overall cost for MRES to provide energy to all 61 members, which then benefits members like Sioux Center. MRES is primarily funding the \$24 million proj-

In addition, this generation will provide emergency power in an extreme situation in which power supply was cut off to Sioux Center. This 11 megawatts of generation would partially power the town, which has a peak demand of about 27 megawatts. The generators will be equipped with backup batteries and be able to run even if power to them is cut, Electric Department head Ezra Weikert said.

"This facility doesn't need to be connected to the grid to start," Weikert said. "With this generation, if we lose power transmission from outside Sioux Center, we would have something we could do to take care of our citizens."

Library struggles to get new books

As a long time distributor, Baker and Taylor had a robust system allowing libraries to make standing orders on authors and series, sending books a week before release, and giving libraries time to catalog and prepare books beforehand.

For the Sioux Center library, which had over 500 standing orders on authors, the system made it easy to acquire new releases as soon as possible.

"Baker and Taylor, just being the granddaddy of them all, had an amazing interface. There really isn't anyone else who has that good of an interface," Bibly said. "They had it set up so neatly on the back end, you can look at what's coming in and your standing orders."

Bilby noted that readers in Sioux Center have been gracious and patient with their response, but avid followers of new series and bestsellers have been forced to wait.

"People who follow them closely, want them. They know they come out Tuesday, and they hope to be first on the list," Bilby said.

Bilby did note that online readers have been unaffected by the closure.

"Hasn't affected Libby at physical books," she said.

Baker and Taylor also provided other services beyond distributing books. The company also processed books for libraries, meaning they would add protection and bar codes to the books for libraries.

"For a lot of libraries this is a, 'Whoa, we have to go back to square one and figure out how to get these books covered again.' We don't notice that, but other libraries do," Bibly said.

While Sioux Center still processes books in house and isn't affected in this area, the closure of Baker and Taylor's interface is another major

"Every year when public libraries fill out an annual

report or survey it goes through their offshoot company. That's going belly-up as well, so the whole state has to figure out how to do their annual reporting," Bibly said.

The data goes back to 2000 and unless Sioux Center and other libraries go back and download the files, it will all be deleted.

Finding new distributors is a challenge, as each has their own limitations.

"I'm looking at companies who only do kids books, or large print. Baker did it all, that's what was nice about them," Bilby said.

Other major distributors such as Ingram Library Services are currently not accepting new orders due to an overwhelming number of requests. Meanwhile, companies like Amazon don't ship books prior to a release date, making it harder for libraries to offer books the same day.

Backfilling previous orders is a struggle for Sioux Center library as well.

"This started months ago so those books should have been paid for out of last year's fiscal year's budget," Bilby said. "We're into the next fiscal year and we have to pay for this year's books and half last year's books. It's kind of messy."

Interlibrary loan is also not all. People using that are still a viable solution for patrons getting it ready to go. It's just as other public libraries are experiencing the same issues. Even the ones that would have a book won't offer it for a period of time as Bilby explains.

> "When we get a new book we hold it back for a few months before we let it go out in interlibrary loan," Bilby said. "We want our own community to use it and have a chance before it disappears for a while. You usually can get a new book via interlibrary loan."

> The changes have forced the library to completely rework their previous system.

> "You kind of feel like you have your process in place, everything flowed smoothly. Now we're all going oh no," Bilby said. "Now where do we go?"
