Time to be generous



Mangold GOD'S WORD MINISTRIES

Scripture encourages being good stewards of what God provides for His people. Luke 11-16 contrasts the unfaithful stewardship of religious leaders, with the sinners' response of repentance and faith in Jesus. Let's continue exploring "principles of giving" (published by efca.org):

GIVING IS

Giving is for all believers, though some are uniquely gifted in this area. "Having gifts that differ according to the grace given to us, let us use them in proportion to our faith, in serving, in teaching, in exhorting, with zeal, with cheerfulness, and the one who contributes, in generosity" (Rom 12.6-8). Again, God provides, and we respond to His grace.

Giving appropriates God's wealth to enable you to give more. "Do good and lend and expect nothing in return, and your reward will be great. Be merciful even as your Father is merciful. Give and it will be given to you, good measure, pressed down, shaken together, running over will be put into your lap. For with the measure you give it will be measured back to you" (Luke 6).

Giving is generous, because it all belongs to God. "The point is this: whoever sows sparingly will also reap sparingly, and whoever sows bountifully will also reap bountifully" (2 Cor 9.6). Because all that you have is from God, and it's all for God, for His purposes.

GIVING IS NOT

Giving is not legalistic. "Speak to the people of Israel, that they take for Me a contribution. From every man whose heart moves him, you shall receive the contribution" (Exodus 25.2). Giving is not ritualistic, but personal, willing worship, heart, mind, will.

Giving is not a set amount. "Each one must give as he has decided in his heart, not reluctantly or under compulsion, for God loves a cheerful giver" (2 Cor 9.7). Trust Him, and give. Giving is not just a token. "They gave according to their means, and beyond their means, of their own accord, earnestly taking part in relief of the saints. And they gave themselves first to the Lord. See that you excel in this act of grace also" (2 Cor 8.3-4,7). Give yourself first to the Lord! Giving is not just for emergencies. "Now con-

cerning the collection for the saints, as I directed the churches of Galatia, so you also are to do. On the first day of every week, each of you

is to put something aside and store it up, as he may prosper, so that there will be no collecting when I come" (1 Cor 16.1-2). You will be ready to respond to emergencies and special opportunities, because giving is planned and regular, as you lay aside something every week.

Giving is not a means of earning favor with God. "For by grace you have been saved through faith. And this is not your own doing, it is the gift of God, not a result of works, so that no one may boast. For we are His workmanship, created in Christ Jesus for good works, which God prepared beforehand that we should walk in them" (Ephesians 2.8-10).

None of your works could ever gain favor with God, only receiving the work of Christ. Then your faith results in works. Including giving back to God what is His, as you trust and obey.

Giving is not an automatic promise of blessing (contrary to how scores of counterfeit teachers mislead people around the world). "I have learned in whatever situation I am, to be content. I know how to be brought low, and I know how to abound, in any and every circum stance. I have learned the secret of facing plenty and hunger, abundance and need. I can do all things through Christ who strengthens me" (Philippians 4.11-12). Jesus is Lord of your life!

"He who supplies seed to the sower and bread for food will supply, and multiply, your seed for sowing, and increase your harvest of righteousness" (2 Cor 9.10). God is at work in your life!

"Every faculty you have, your power of thinking or of moving from moment to moment, is given you by God," CS Lewis observed. He owns all your time, talent, and treasure.

"One thing is sure" R.K. Hughes noted, "your worldly wealth will go somewhere. You cannot hang on to it. One day your most precious things will fit in a hospital drawer. The only wealth that will endure is that which has been invested in others for the sake of Christ and His gospel."

The apostle says, "To this end we always pray for you, that our God may make you worthy of His calling, and may fulfill every resolve for good and every work of faith, by His power, so that the name of our Lord Jesus may be glorified in you, and you in Him, according to the grace of our God and the Lord Jesus Christ" (2 Thess 1.11). How will you respond?


