Employee performance evaluations were discussed. Council would like to see employee wages brought closer to the local average and feels both employees perform their duties well. Motion by Wedemeyer second by Acker to give a 7% raise to Tim Knapp and Gwen Blass effective October 6, 2025; Ayes - Blake, Acker and Wedemeyer, Absent - Richter and Schiller.

Public Works Director starting wage expectation were discussed. Council stated that wage would vary depending on what certifications the new employee has. Council would start at a base pay and add \$1.00 per hour for each certification received to keep wages close to the local average. Motion by Wedemeyer second by Blake to have Public Works Director perspective starting pay range from \$27.00 to \$32.00 per hour; Ayes - Blake, Acker and Wedemever, Absent - Richter and Schiller.

Discussion held regarding Draman nuisance properties. Joey Draman informed council that he is working with a potential buyer for 606 Wallace St. Joey is also working with Guthrie County to start the Estate process for property at 105 W 3rd St to get it titled into his name. He is working on selling this property with the stipulation that the existing nuisance violations be removed by potential buyer in a timely manner. Joey also requested that the council remove the CDBG lien on the property to help get the property sold. Motion by Blake second by Wedemeyer to agree to forgive the CDBG lien with stipulation in purchase agreement that the buyer agrees to remove the house within 60 days of date of closing; Ayes - Blake, Acker and Wedemeyer, Absent - Richter and Schiller. Council would like the clerk to verify this with Region 12 COG.

Jennifer Ackerson a Mi-Tech right of way agent presented two easement requests for the Alliant Energy underground line project in Casey. Easement #005 is a buried line located at parcel #0001132700 and Easement #016 is buried line and an electric box located at parcel #0001131001 on the West side of Water Plant building. Motion by Acker second by Wedemeyer to approve easements #005 and #016 with MiTech Co.; Ayes – Blake, Acker and Wedemeyer, Absent - Richter and Schiller. Jennifer will get more details regarding the needs for the pot hole dump site.

Blass provided a written clerks report. Blass reminded council she will be gone Oct 15th thru 17th at the IMFOA meeting in Des Moines, discussed need for a budget amendment for Water Project retainage payment and Community Building sprinkler system, setting a date for the public works interviews, Guthrie County Youth Foundation dues, vacation request and presented the recently revised Guthrie County ordinance on animal control. Motion by Wedemeyer second by Blake to approve Resolution #2025-14 setting the date for Budget Amendment Public Hearing for November 3, 2025; Roll Call Vote: Ayes Blake, Acker and Wedemeyer, Absent - Richter and Schiller. Motion by Wedemeyer second by Blake to set the date of October 13, 2025 for public works interviews starting at 5:00 pm; Ayes - Blake, Acker and Wedemeyer, Absent Richter and Schiller. Motion by Wedemeyer second by Blake to pay Guthrie County Youth Foundation dues; Ayes - Blake, Acker and Wedemeyer, Absent - Richter and Schiller. Motion by Blake second by Wedemeyer to approve vacation of October 30th - 31st and November 25th - December 1st for Blass; Ayes – Blake, Acker and Wedemeyer, Absent – Richter and Schiller.

Mayor Vorm and Tim Knapp updated council about water and sewer systems. Vorm inquired about the need to continue to put Fluoride into the Casey water system since it is hazardous and not required by State or Federal government. Council agreed they would like to continue to have Fluoride in the water system. Vorm and Blass informed council that IA DNR has approved the application to have Jon Welker perform public works Affidavit duties on a weekly basis for the City of Casey. Motion by Wedemeyer second by Blake to set pay of \$400 per month for the Public Works Affidavit until Casey no longer needs an Affidavit; Ayes – Blake, Acker and Wedemeyer, Absent – Richter and Schiller.

Always stay in the kitchen while frying, grilling or broiling, and keep flammable items such as potholders, paper towels and wooden utensils away from the cooking area. Additionally, clean your stove and oven regularly to prevent grease buildup, which can catch fire, and keep a fire extinguisher within easy

Keep Flammable Materials at Bay Store gasoline, propane and other flammable liquids in approved containers and keep them in a well-ventilated area, away from heat sources and out of reach of children. Ensure your home is free of excessive clutter, especially in the basement, attic and garage, which can fuel a fire and make it harder to escape.

Maintain Electrical Safety
