## Austin Rasmussen, jr. Exira-EHK boys track



t's been a busy spring for Austin Rasmussen.

In addition to keeping up his golf game – he had a good score of 43 on the back nine of the Atlantic Golf & Country Club in this week's Rolling Valley Confererence round-robin meet - he's been tearing it up on the track.

Rasmussen's latest efforts brought him a win, coming at Tuesday's CAM Cougar Classic. After shadowing Woodbine's Evan Estrada most of the way in the 3200-meter run, he pulled ahead late to win the event in 10:49.45, 27 seconds ahead of Estrada.

Rasmussen came back to take third in the 1600-meter run, an event he's won in the past.

Within the Rolling Valley Conference, Rasmussen's best time ranks him second in the 3200-meter (behind Estrada, so he beat him) and third in the 1600-meter run.

Here's to contiued improvement and a push toward state. Great job, Austin!
