However, Schultz said after doing research on the topic learned the use of eminent domain and carbon dioxide is part of Iowa Code.

"The legislature put carbon dioxide in the Iowa Code in 1985 as a proactive permissional use of eminent domain," Schultz said. "(After) talking to the Iowa Utilities Commission (I learned that it happened) because of (a) farmer investor ethanol plant in Denison (around 1983 and 1984)

That investor group wanted to sell their carbon dioxide to IBP (Iowa Beef Packers who had a location) a quarter (and/or) half mile down the road (from the plant).. But there was corporate property inbetween. So instead of saying carbon dioxide is eligible for up to a mile or under five miles (for eminent domain) they just left it completely wide open (and a) multi-100 mile project was proposed."

Schultz also said article 1 section 10 of Iowa Constitution says, "Iowa will not pass a law invalidating contract language which is already in effect under Iowa law," and he was worried if Summit Carbon Solutions had a contract with landowners, that could open Iowa up to legal issues.
