Last year was a record-breaking season for AC/GC Chargers girls' basketball, and now, they are ready to face another year together.

The girls' basketball program played in the first Regional Championship game in AC/GC school history last season. While the result was a loss to Eddyville-Blakesburg-Freemont, and while the loss hurt, the team wants to focus on this season, not what is behind them.

"This is a whole new season and team with new faces. We preach getting better every single day and focusing on the small things. Keeping a positive energy with each other and focusing on playing our best ball by the end of the season. If we do those things, good things will happen," Head Coach Brad Baudler said.

Perhaps the most significant difference between last year and this year is the loss of the team's lone senior, Shay Lemke. Lemke was phenomenal from her point guard spot, leading the team in assists. This year, a familiar face is stepping into that role in Meranda Gruber.

"She is learning and growing every day, and I'm excited to see how she progresses throughout the season. We don't expect

her to be Shay but her own person and be confident in her strengths," Baudler added.

There is plenty for Gruber to be confident in. Out of the players who played in all 24 games last year but never drew a start, Gruber led in points, steals, and assists. While most of the team remains intact, five freshmen have been welcomed to the program this year.

"All five freshmen have really brought it in practice. The level of competitiveness and energy is contagious. I'm happy where we are with our team at this time," Baudler said.

One of this year's returners is Camdyn Richter. Richter led the team in points last year with 361, which was also an AC/GC single-season record. The nowsenior sits at 645 points for her career, and if she has a season like last year, she can surpass 1,000 points. Richter knows that this is a new season, and success isn't always guaranteed.

"The biggest thing is understanding that what I did last season doesn't automatically carry over. I have to earn it again. Setting high expectations for me and my team is something I value a lot. I've focused a lot on expanding my game, especially on the three-point line and in other positions. I've also

worked on getting stronger and improving my decision-making so I can create better opportunities for my teammates as well as myself," Richter said.

This year's senior class is filled with talent, and another big piece to the team will be Becca Littler. She was second on the team in assists, and added 80 rebounds, 77 steals, and 150 points. Among this year's returning starters, she also had the highest assist-to-turnover ratio, at 1.14. Littler credits her ability to set teammates up with good looks to her scoring ability.

"If the defense respects me on offense, it opens up other looks for my teammates. My teammates work hard, especially in the paint to post up and get open, so it's easy for me to be able to hit them. I also believe that when everyone on the court is able to get good looks, our offense is balanced out and efficient," Littler said.

Another big storyline? The continued emergency of Stella Largent. She has continued to improve each year, and last year she set a career-high with 246 points, which was just her sophomore campaign. This year, Largent's goal is to continue to make an impact on both ends of

"We play an aggressive style

defense, and I want to continue to rebound well and create turnovers. I've worked on my shot a lot. Offensively, I want to shoot at a high percentage, take the open shot, and create offensive opportunities for myself and for my teammates," Largent said.

The one thing this program has shown over the past few years is that it knows how to win. Last vear, they recorded the most wins in AC/GC school history (22) and the highest winning percentage (.917). They won 16 games in a row, matching their entire win total from the year prior, before losing in the regional championship game. These girls, along with Baudler, have set the tone for this year.

"Together is our word this year If we stick together, anything is possible. We have a mission and vision statement that we address every week, but after that, it is the small details that we continue to improve on. When we improve in those areas, that's when we start to see something special. Head to the ground and taking one day and game at a time is the goal," Baudler concluded.
