### Improve Vegetable System Weed Management with Tarping

New resource from ISU Extension and Outreach outlines using tarps in vegetable growing

Managing weeds is one of the greatest challenges for vegetable growers, accounting for significant yield loss each year. While cultivation and herbicide use can combat weed growth, over time, these methods can cause soil erosion issues and human health concerns.

A new resource from Iowa State University Extension and Outreach offers guidance on an excellent weed management alternative: tarping.

"Tarping to Improve Weed Management and Reduce Tillage in Vegetable Systems" outlines methods of tarping use and provides information on tarp implementation and installation.

Publication co-author and graduate research assistant in the ISU Department of Horticulture, Carly Strauser, 8-4-tfc noted its benefits.

> "Tarps can provide many of the same functions tillage does, such as killing weeds or decomposing cover crops, making it great for no-till systems. They are a great investment for growers and are relatively inexpensive because they are multifunctional and can be used for multiple years," she said.

The resource also demonstrates the effectiveness of two tarping processes: occulation and solarization.

Occulation aims to kill weeds by blocking access to sunlight with a black and white tarp, which prevents weeds from photosynthesizing. Solarization uses a clear tarp to create a warm environment, killing weeds due to excess heat.

Ajay Nair, professor and chair of the Department of Horticulture at Iowa State University, shared the findings of the study in the resource.

"Spring temperatures in the north central United States are typically not warm enough to terminate weeds via solarization," he said. "Clear tarp treatments and notarp control treatments required cultivation to terminate weeds prior to planting the cash crop, whereas black and white tarps did not."

The four-page publication is available for download through the ISU Extension Store.

#### TAYLOR COUNTY PUBLIC NOTICE

To: All property owners and tenants in Taylor County, Iowa. You are hereby notified that the Board of Supervisors for Taylor County, Iowa, in accordance with 2019 Code of Iowa, chapter 317 has ordered a program of weed destruction to be followed by landowners and tenants who are expected to destroy and immediately keep under control any areas infested with any noxious weeds. Destruction may be accomplished by spraying, cutting, or any means which prevents seed production. All noxious weeds should be destroyed by:

June 1, 2025, for Leafy Spurge; Perennial Peppergrass; Buckthorn (Rhamnus, not to include Rhamnus Frangula); Sour Dock Perennial, Smooth Dock Perennial, Sheep Sorrel Perennial, Russian Knapweed, Buckhorn Perennial, and Wild Mustard Annual, and all other species of thistles belonging in genera of Cirsium and Carduus, (Musk Thistles).

June 15, 2025, for European Morning Glory, or Field Bindweed, Wild Carrot Biennial, also known as Queen Anne's Lace, Teasel Biennial, Canada Thistle, Poison Hemlock, Multiflora Rose, and Palmer Amaranth which is now listed for eradication.

July 15, 2025, for Horse Nettle, Perennial Sow Thistle, Quack grass, Butterprint Annual, Cocklebur, Bull Thistle, Wild Sunflower Annual, Puncture Vine Annual, Shattercane Annual.

thistle Musk in field"Once plants have bolted, cutting or mowing stems will reduce or perhaps prevent seed production," Anderson said. "Chopping individual plants with a spade below ground level is also highly effective but labor-intensive."

Musk and bull thistles are common invasive weeds in Iowa pastures, and both are biennial, meaning they can be easier to control than the perennial Canada thistle. Biennial thistles of Iowa, an online resource from Iowa State's Integrated Crop Management program, has descriptions, comparisons, and control options for musk and bull thistles.

You are hereby notified to destroy or cause to be destroyed and, as often as necessary, to control the growth, all noxious weeds growing on your property located within Taylor County, Iowa, on or before the dates fixed for the destruction of each group of noxious weeds, as stated herein, and that unless you destroy or cause the same to be destroyed, the Board of Supervisors of Taylor County, Iowa will cause said weeds growing upon said lands to be destroyed and the cost thereof to be taxed against said lands as provided in Chapter 317 of the Code of Iowa and amendment thereto.
