City of New Market - Mowing Notice Warmer weather is just around the corner! So here's a timely reminder

Under Chapter 50 of the City Code any property within the City, whether vacated or non-vacated, is required to be mowed any time the vegetation reaches a height of more than eight (8) inches by the first (1st) and fifteenth (15th) day of the month in April, May, June, July, August, September, and October of each year.

If the City finds a property in violation of this chapter, one (1) letter and a copy of this chapter will be sent by regular mail to the property owner and or tenant. This letter will require immediate and continued compliance. Any property owner/tenant that violates the provisions of this chapter will be given one (1) notice per season. The City will be additional violations without additional authorized to respond to written notice being given.

Any property owners that have failed to mow their properties, thus allowing them to be moved by the city, will be billed at the following rate per occurrence. Mowing and trimming at \$100.00 per hour per employee (1 hour minimum) plus a \$100.00 surcharge.

AN ORDINANCE TO AMEND THE MUNICIPAL CODE OF THE CITY OF NEW MARKET, IOWA BY AMENDING PROVISIONS PERTAINING TO WATER CHAPTERS 90, 91 & 92.

NOTICE IS HEREBY GIVEN, that the New Market City Council proposes to adopt Ordinance #256 setting forth a proposal to amend Chapters and sections 90.01-92.10 of the New Market Iowa Code of Ordinances, described as follows: 90.06 COMPLIANCE WITH PLUMBING CODE. The installa-

water service pipe and any connection with the water system shall comply with all pertinent and applicable provisions, whether regulatory, procedural or enforcement provisions, of Division 4, Plumbing Rules and Regulations, of the State Building Code. 90.09 TAPPING MAINS

4. Location Record. An accurate and dimensional sketch showing the exact location of the tap shall be filed with the Superintendent in such form as the Superintendent shall require. A tracer wire is required with installation of poly pipe.

90.10 INSTALLATION OF WATER SERVICE PIPE. Water service pipes from the main to the meter shall by Type K copper or poly pipe. The use of poly pipe requires additional installation of a tracer wire. The use of any other pipe material for the service line shall first be approved by the Superintendent. Pipe must be laid sufficiently waving, and to such depth, as to prevent rupture from settlement or freezing.

90.11 RESPONSIBILY FOR WATER SERVICE PIPE. The last sentence shall read: There shall be a corporation connecting to the main with 3/4" or 1" K copper, buried to 5 feet deep, running from the water main to a curb box with a stop and waste, 3/4" or 1" K copper from the curb box into the meter pit to a shut-off valve placed inside

90.13 CURB VALVE. There shall be installed within the public right-of-way a main shut-off valve on the water service pipe and a meter pit of a pattern approved by the Superintendent. The shut-off valve and meter pit shall be constructed to be visible and even with the pavement or ground.

90.19 CROSS CONNECTION: BACKFLOW PREVENTION. When the Public Works Director concludes that a possible cross connection exists in a private residence, business or industry, or that a backflow condition could result, that customer will take action deemed appropriate or install devices approved by the Public Works Director to correct this problem. All costs will be borne by the owner, and any violations of this provision will result in immediate termination of City services until the problem is corrected. Testing of Backflow Prevention assemblies shall be made following the Manufacture's

91.04 LOCATION OF METERS. All meters shall be located in the meter pit so that they are easily accessible to meter readers and repairmen and protected from freezing.

91.05 METER SETTING. The property owner shall provide all necessary piping and fittings for proper setting of the meter including a valve on the discharge side of the meter. Meter pits are required with approval of the Superintendent and shall be of a design and construction approved by the Superintendent.

92.04 BILLING FOR WATER SERVICE.

4. Door Knocker Fee. Bills not paid by the 20th of the month after their due date shall receive a five-dollar (\$5.00) fee added to their account. A door knocker will be hung on their door with a final notice of service scheduled to disconnect on the 25th of the month.

5. Customers shall be billed a service fee of \$2 per month to be held in a reserve fund for future repair needs. The service fee shall be raised by 3% with inflation each fiscal year on July 1.

92.10 TEMPORARY VACANCY. A property owner may request water service be temporarily discontinued and shut off at the curb valve when the property is expected to be vacant for an extended period of time (Maximum of 5 months turned off). There shall be a ten dollar (\$10.00) fee collected for shutting the water off at the curb valve and a ten dollar (\$10.00) fee for restoring service. During a period when service is temporarily discontinued as provided herein there shall be no minimum service charge. The City will not drain pipes or pull meters for temporary vacancies.

Improve Vegetable System Weed Management with Tarping

Managing weeds is one of the greatest challenges for vegetable growers, accounting for significant yield loss each year. While cultivation and herbicide use can combat weed growth, over time, these methods can cause soil erosion issues and human health concerns.

A new resource from Iowa State University Extension and Outreach offers guidance on an excellent weed management alternative: tarping.

"Tarping to Improve Weed Management and Reduce Tillage in Vegetable Systems" outlines methods of tarping use and provides information on tarp implementation and installation.

Publication co-author and graduate research assistant in the ISU Department of Horticulture, Carly Strauser, noted its benefits.

"Tarps can provide many of the same functions tillage does, such as killing weeds or decomposing cover crops, making it great for no-till systems. They

are a great investment for growers and are relatively inexpensive because they are multifunctional and can be used for multiple years," she said.

The resource also demonstrates the effectiveness of two tarping processes: occulation and solarization.

Occulation aims to kill weeds by blocking access to sunlight with a black and white tarp, which prevents weeds from photosynthesizing. Solarization uses a clear tarp to create a warm environment, killing weeds due to excess heat.

Ajay Nair, professor and chair of the Department of Horticulture at Iowa State University, shared the findings of the study in the resource.

"Spring temperatures in the north central United States are typically not warm enough to terminate weeds via solarization," he said. "Clear tarp treatments and no-tarp control treatments required cultivation to terminate weeds prior to planting the cash crop, whereas black and white tarps did not."
