Working alongside Werden for many years, Steger said he's always gotten along well with him. Looking back at his sudden passing, Steger said it was "very much a shock."

The most rewarding part of his work, Steger said, is having the opportunity to help victims.

"When I do the county work, it's more about helping victims," Steger said. "My focus is making sure that victims are taken care of and that if something bad happens to them, people that are responsible face the justice system, so I find a lot of reward in just helping."

Since he was sworn into the role, Steger feels it's been going well so far. Already being familiar with the county attorney's office, he said it hasn't been too difficult to adjust to the role.

"I think it's an important role in the community, making sure that the legal system operates well," Steger said. "It's really a key component of every county to have a good, solid county attorney actively prosecuting cases and making sure that that system is in place and working well."

For example, he mentioned knowing parents and grandparents who've given a significant amount of money to callers claiming to be political lobbyists.

"They would attach to that a sense of social responsibility and even religious duty to say, 'Well, don't you care about X, Y or Z? Because you can make a significant difference if you just help us get across this threshold of fundraising so that we can lobby properly for the causes that you care about," he said. "I don't know what to do about that exactly, but to be in conversation particularly with parents, grandparents and so on, who may be particularly susceptible to that."

Lisa Irlbeck, the marketing director for Availa Bank and coalition member, said the Carroll County Fraud Coalition is open to feedback and ideas on how they help spread awareness for the issue.

"We're just trying to protect the people in Carroll County, because we see it every day too," Irlbeck said. "Not only are we seeing it every day at the bank, but then thinking of the people who don't come in and tell you."

the team is also excited to offer two outdoor spaces one upstairs and one downstairs - as well as a community room, an underground parking garage and storage units.

By acquiring different tax credits awards in the past, Schweers said it substantially helped fund the project

The Carroll County Board of Supervisors held their regularly scheduled meeting on May 12, 2025, at 9:00 a.m. in the Boardroom.


The first item on the agenda was the City of Manning with their Park Avenue Neighborhood Revitalization Grant asking for support for it. After discussion it was approved to support the Grant with \$20,000 for each Fiscal Year 2026 and 2027,

for a total of \$40,000. The Board then reviewed and approved a Plat for Larry Lasher Revocable Trust in Sheridan Township, Section

The Supervisors then reviewed and approved the FY 26 Contract Law Enforcement Rates to the Contract Cities with a 2% increase.

The Board then set a Public Hearing for a Petition to Vacate a Survey in Grant Township, Section 8 for Ralph Von Qualen on June 2, 2025, at 9:00 a.m.

At 9:30 a.m. the Board held a Public Hearing on ship, Section 16. The Board

expense was \$575,000 for resurfacing a road project south of Dedham that was pushed up a year due to bids that were underestimated. Other expenses were Medical Examiner, Overtime in Sheriff's due to injuries, unexpected equipment repairs, and numerous others along with some cleanup of accounts. There was no public comment at the Hearing.

The Board then approved the Appropriations Resolution of the Budget Amend-

The Supervisors then considered and approved the **Annual Engineer Contract** with a 3 1/2% increase.

The Engineer then gave a Construction update. He reported the Resurfacing south of Dedham was complete, South of Manning should be completed the middle of last week and Lidderdale and Mount Carmel projects should be completed in the next two weeks.

The contractor is driving Piling on the Bridge south of Ralston, and there will be a crew in the County doing asphalt patching and cutting rumble strips.

The Board approved payables for the period in the amount of \$1,093,108.75.

The Board then approved Interfund Transfers the largest of \$232,682.93 from Recovery Fund back to Lost Fund (Funds not needed in the remodel of Courthouse),

two other transfers to zero out accounts (.46 cents and \$14.38).

The Board then reviewed consisted of ship, Section 25. The Board and approved Proposed Changes to Employee Handbook (effective for new hires after 7/1/25). Those changes being after 6 months of continuous Service get 5 days of Vacation, after 1 year 10 days with the rest of current schedule remaining as current; on sick leave for hires after 7/1/25 will get only 1 day per month instead of 1 1/2.; and expense reports need to have itemized statement included.

The Board reviewed and considered Proposed Quotes for New roofing on the Canopy of the Courthouse. Three quotes were received from ForSure, Brincks Exterior and Elevate Roofing. The Board approved the Brincks Exterior for \$11,121.34.
