Additions to the agenda: ash trees update and curb on 207 W. 2nd St. Drake motioned to approve the agenda with the additions; Mikkelsen seconded. Motion carried.

Drake motioned to approve the consent agenda; Riesselman seconded. Mo-

tion carried.

Fire Dept. Report – Borkowski stated received 6 – 3year old cylinders from the city of Renwick. Car show is scheduled for Aug. 31, 2025.

Public works report- Grossman stated concession stand water heater not working. Council agreed to wait on purchasing another one for this year. No longer use the two chimneys on roof of Community Center. Council agreed to cover them. Water tower gravity valve stuck open, if continue to have problems

City truck- table Street Project – Sturm stated waiting for USDA to approve loan before the project can go out for bids. Snyder questioned the sink hole on 4th street and culvert on 1st street and gave options to repair.

Community Center – consider options: repair, sell, or remodel.

Burn site - After submitting the city offer to Sacred Heart Parish in Manning, the offer has been sent to the diocese for approval.

Insurance rates – Greteman with EMC insurance presented a quote for city insurance.

Hail damage quote - Motion made by Mikkelsen to get quotes for the hail damage to the community center and fire station, seconded by Drake. Motion carried.

Software update – City Clerk stated all reviews on the new Alpha Edition software were excellent. Drake motioned to approve the software change, seconded by Riesselman only if it doesn't interfere with the training of the new city clerk. Motion carried. Storm Sewer Drain Repair – The storm sewer drain on 1st street needs repair. Sturm stated could use a lining.
