RESOLUTION NO. 24-12 RESOLUTION SETTING WEED CONTROL AND GRASS MOWING FEES

WHEREAS, Aurelia City Code Chapter 50, Article 2, Section 9 (50.02.09) defines weeds, vines, brush or noxious growths of any kind of grass over 12 inches tall or other vegetation upon any lot or parcel of ground including upon the parking or in the alley so as to constitute a health, safety or fire hazard.

WHERAS, the City of Aurelia Public Works Department will take over the task, and upon proper notification, will abate the nuisance or condition of neglect.

WHEREAS, the City of Aurelia is authorized to charge fees to a property owner for the abatement of grass, weeds, vines, and brush. The fees for cutting grass, weeds, vines or brush by the City as a result of abatement proceedings under Chapter 50 shall be as follows:

Base Fee Plus Additional Charge 1st time in one calendar year

\$100.00 \$75.00 per hour 2nd time in one calendar year \$150.00 \$75.00 per hour

3rd time in one calendar year \$200.00 \$75.00 per hour

NOW, THEREFORE BE IT AD-OPTED AND RESOLVED, that the Aurelia City Council hereby approves and adopts the above listed fees.

This resolution shall become effective on July 15, 2024 upon its passage and approval as provided by law.
