

Forage Field Day in Western Iowa to focus on Summer Annuals

AMES, IA- Iowa State University Extension and Outreach, in partnership with I-29 Moo University and the Northern Plains Forage Association, invites producers, agronomists and forage enthusiasts to attend the 2025 Forage Field Day on July 31 at the Western Research and Demonstration Farm near Castana, Iowa.

This all-day event will be held from 9 a.m. to 3 p.m. and feature field demonstrations, expert talks and hands-on learning opportunities.

Forage topics will focus on summer annuals for silage, baleage and grazing, interseeding strategies, as well as pasture management.

Attendees will hear from leading Iowa State University researchers and industry professionals on topics such as the agronomics of grazing summer annuals, sorghum breeding objectives, interseeding summer annuals into alfalfa and heifer grazing economics

Highlights from the day will include:

Field demonstrations of forage sorghum for silage, summer annual grazing systems, and nitrate and prussic acid testing.

Live nitrate and prussic acid testing demos to enhance in-season decisionmaking

Interactive forage and weed ID competition with prizes

Expert insights on topics ranging from grazing economics to breeding priorities for sorghum and strategies to extend alfalfa stand life

"This field day is a great opportunity to see the versatility of summer annuals in action-whether for silage, grazing or interseeding," said Shelby Gruss, extension forage specialist with ISU. "These crops offer flexible options to fill forage gaps, extend alfalfa stands and improve both productivity and profitability across diverse forage systems."

The cost to attend the field day is \$20 for individuals or \$50 for farms and family groups up to 5 people.

All participants are asked to register online by July 21 to be eligible for a door prize. Members of the Northern Plains Forage Association may attend for free, but must register in advance for an accurate food count.

A complimentary lunch will be provided under the hoop barn, where participants can test their forage ID skills and network with speakers and fellow attendees.

lins to approve a \$27.25 per hour wage authorization for John Galvin, Deputy, effective June 23, 2025. Motion car ried

Skou to approve a \$20.50 per hour wage authorization for Jennifer Ohlendorf, Jailer, effective June 16, 2025. Motion carried.

Rhonda Thompson, Hopkins Insurance, presented the county's July 1st renewal from Iowa Communities Assurance Pool (ICAP) for auto, property and liability insurance coverage with a 5.45% premium increase. Thompson reported the increase is a result of total valuations of county property and vehicles increasing by 1.3 million directly related to ICAP implementing an annual built in inflation valuation increase of 2% on all buildings and business personal property. The supervisors reviewed potential cost savings if deductibles were increased and the county assumed more exposure. Cybersecurity coverage was also discussed at length and consensus was that current coverage may not be adequate in today's technology environment.

Motion by Skou, seconded by Bellefy to renew the Iowa Communi ties Assurance Pool (ICAP) insurance policy for 2025/2026 including an increase in cyber liability coverage with a total premium of \$312,808.00. Motion carried.

Thompson presented the county's worker's compensation insurance policy renewal for 2025/2026. The county's total premium for workman's compensation insurance decreased by \$37,597.00 due to a previous large employee payout falling off the claims history which decreased the mod factor from .95 to .65 in addition to a 25% discount for longevity and loss experi-

Motion by Mullins, seconded by Skou to renew the Iowa Municipalities Workers Compensation Association (IMWCA) insurance policy for 2025/2026 with a \$30,206.00 premium. Motion carried.

Motion by Skou, seconded by Mullins to approve Resolution #2025-14 Inter-Fund Operating Transfer of \$1,050,000.00 from Rural Basic Fund to Secondary Road Fund effective June 10, 2025. Roll call vote: Mullinsaye, Bellefy-aye, Skou-aye, Petersenaye. Motion carried and resolution adopted.

Motion by Skou, seconded by Mullins to acknowledge a \$90,068.81 (\$3,046 increase) salary adjustment for Joel Ehrig, County Assessor, effective July 1, 2025 as previously approved by the Assessor's Conference Board. Motion carried.

Motion by Mullins, seconded by Bellefy to acknowledge a \$72,055.04 (\$6,788 increase) salary adjustment for Nathanial Story, Chief Deputy Assessor, effective July 1, 2025 as previously approved by the Assessor's Conference Board. Motion carried.

Motion by Mullins, seconded by Bellefy to acknowledge a \$52,213.80 (\$2.95 per hour increase) salary adjustment for Lacey Daum, Assessor's Office Manager, effective June 2, 2025 with no additional increase on July 1, 2025; as previously approved by the Assessor's Conference Board. Motion carried.

Motion by Skou, seconded by Mullins to approve a separation of employment and \$3,465.86 final payout of hours worked, vacation and longevity hours for Nissa White, Assessor's Office Manager, effective May 30, 2025. Motion carried.

Motion by Skou, seconded by Mullins to approve a "Cherokee County Provider and Program Participation Agreement" for fiscal year 2026 county funding of covered services provided by Siouxland Regional Transit System for the benefit of Cherokee County citizens and individuals. Motion carried.
