Help stop state destruction of Iowa Historical Society materials State's current plan could disappear generations worth of

Iowa historical treasures

Concerned Iowans across the state have launched the SAVE IOWA HISTORY coalition, calling on state leaders to stop reckless removal of one-of-a-kind historical records and artifacts from the State Historical Society's Iowa City Research Center.

Founded in 1857, the State Historical Society of Iowa (SHSI) "preserves and provides access to Iowa's historical resources," and Iowa State Code requires Iowa to maintain SHSI facilities in Des Moines and Iowa City to fulfill this mission.

This summer, Iowa's governor announced plans to close SHSI's Iowa City Research Center, without prior notice or input from Iowans or $stakehold\bar{e}rs\,including\,SHSI's$ Board, staff, or partner institutions.

SHSI was placed under the Iowa Department of Administrative Services (DAS) when Governor Reynolds reorganized state government in 2022, and state appropriations to SHSI have continued to decline, compromising the institution's mission.

Now the state is moving ahead with the building closure plan, but without a good plan to preserve and maintain access to the enormous, irreplaceable collections currently housed there.

Because Des Moines SHSI facilities lack space to take in materials from Iowa City, archival could end up warehoused indefinitely in unspecified loca-

Whereas current SHSI facilities are specially built and staffed by trained librarians to keep materials safe in case of floods, fires, or natural disasters, the state has offered no guarantee of safe relocation for SHSI materials, posing the risk that disaster could destroy in a few hours what it has taken Iowans almost two hundred years to build

While placing invaluable materials at risk, the building closure plan also creates major new costs for moving, warehousing, and building demolition that could far exceed any claimed short-term

Iowa history preserved in SHSI collections ranges from hundred-year-old small-town municipal records to family photo collections, letters, Civil War diaries, recordings of oral history interviews, local newspapers, records of Iowa civic and religious organizations, and much more.

SHSI is obligated to provide these resources to researchers, students, genealogists, reporters, and anyone else interested in Iowa history.

Closure of Iowa City's Research Center would cut Iowans off from access to a large to future generations.

State Fair Straw Poll shows 2026 election preferences

DES MOINES - Iowa Secretary of State Paul Pate today announced the results of the unscientific Iowa State Fair Straw Poll.

The poll, which closed Sunday at 8pm, allowed fairgoers to cast their preference for candidates for the 2026 gubernatorial, senatorial, and congressional races.

More than 2,000 fairgoers participated in the 2025 state fair straw poll, using tablets at the Iowa Secretary of State's booth in the Varied Industries Building to select their preferred candidates.

Fairgoers were asked to choose their preferred candidates for the 2026 Primary Election and to vote for their preferred candidate to represent their respective political party in the 2026 General Election.

Secretary Pate emphasized that the poll serves a larger purpose beyond measuring candidate preferences.

"While historically, the straw poll has been a good indicator of where Iowa voters stand in terms of the upcoming election, the real goal of the straw poll is to encourage Iowans to participate in our election process," said Secretary Pate. "We have a City-School election coming up on November 4. Local elections matter. This is the time to truly make your voices heard and have an impact on your local communities. November will be here before we know it - and it's never too early to make your plan
