Six locals named to WIC All-Conference softball teams

OAKLAND - The Western Iowa Conference released their annual softball honors list last weekend after the 2025 state softball tournament concluded. The conference cochampion, Riverside Bulldogs qualified for the state tournament with Treynor and Missouri Valley also ranked this season in their respective classes. Treynor and Riverside tied for the league title this year.

Three local teams each had three players named to the All-Conference teams. AHSTW had Clara Pace on the first team, Sienna Christian on the second team and Loralei Wahling on the honorable mention team. IKM-Manning had Karlee Arp on the first team, Anna Stangl on the second team, and Keagan Eischeid on the honorable mention team. Exira-EHK-Audubon had a pair of second team selections in Riley Miller and Taryn Peterson and an honorable mention selection in Anna Larsen.

For the Lady Vikes of AHSTW, Clara Pace was a first team pick after batting .440 in conference games with 22 hits, 9 doubles, a triple, and 10 RBI's. The freshman catcher threw out five batters trying to steal a base this year. Christian also started eight game pitching and appeared in 15 games this year with an ERA of 4.76. She had 69 strikeouts in 64 and two-thirds innings of WIC Conference games. Christian also hit .467 with 21 hits and 9 RBI's in conference play. Loralei Wahling was an honorable mention team pick after batting .161 and pitching in 12 in- Haedyn Hall, Gracyn Stone; Exira-EHKnings in WIC play.

The Exira-EHK-Audubon Spartans had a pair of second team all-conference selections in Taryn Petersen and Riley Miller.

Riley Miller was second on the team in batting in conference games with a .349 average and 15 hits. Miller also pitched and was 7-6 in WIC games. Miller logged 81 and two-thirds innings with an ERA of 1.63, 114 strikeouts and a save. Opposing batters batted .186 against her in conference play. Petersen batted .419 in nine WIC games with 13 hits, 7 RBI's and an on-base percentage of .438. She also stole seven bases. Petersen Wahling; Logan-Magnolia - Teagan Carritt; also started three games pitching and had a

record of 1-2 in 15.1 innings with an ERA of 3.65 and 24 strikeouts.

Anna Larsen was named to the honorable mention team after leading the Spartans in batting in WIC games with a .340 average, 16 hits and 12 runs scored.

For the IKM-Manning Wolves, WIC leading hitter Karlee Arp was a first team selection. Arp had a batting average of .561 in conference games and .541 in all games. Arp had 23 hits out of her 40 for the season overall in WIC play. She also had 11 RBI's, 7 doubles, an on-base percent of .612. Anna Stangl was second on the Wolves team with a .320 average, 16 hits and an on-base percentage of .404 in conference games and earned a second team selection. Eischeid made the honorable mention team and batted .261 in conference games with 12 hits and 11 RBI's in WIC games. PItching, Eischeid was 5-6 in 11 starts with an ERA of 5.56 in 56 and two-thirds innings. She struck out 50 and walked 46.
