Hawarden man charged for OWI

A 37-year-old Hawarden man was arrested about 4 a.m. Saturday, Oct. 18, near Maurice on charges of first-offense operating while under the influence and no valid driver's license.

The arrest of Francisco Gerardo Lopez-Siles stemmed from a report of an erratic driver who was possibly drunk, last seen traveling east on Highway 10 from the Highway 75 intersection about two miles north of Maurice, according to the Sioux County Sheriff's Office.

A deputy spotted the described 2019 Chevrolet Camaro heading west on Highway 10 from Harrison Avenue about a mile east of the highway 10/75 intersec-

The Camaro was failing to medical treatment. maintain its lane and twice swerved off the highway and improper use of lanes and was stopped at the highway 10/75 intersection.

Lopez-Siles had bloodshot/watery eyes, impaired balance, slurred speech and the odor of an alcoholic beverage and failed field sobriety tests.
