served, may serve his sentence at the Woodbury County, Iowa Jail at his own arrangement and expense, may serve said sentence by way of electronic monitoring for four (4) days through the Sioux County Sheriff's Office Electronic Monitoring Program ("EM"), shall pay a \$430.00 fine, 15% crime services surcharge and court costs of \$100.00, shall be placed on probation for a period of one (1) year, shall pay a \$300.00 statutory probation supervision fee, shall pay restitution in the amount of \$616.81 to be paid over to Hy-Vee Food Stores, Sioux Center.



• Operator Knowledge Exams-8:00am-3:30pm

• CDL Knowledge Exams-8:00am-2:30pm

• All drive tests are done by appointment only.

• Valid insurance documentation and vehicle registration are required for all driving tests.

• We do not do CDL or Motorcycle drive test.

• No Real ID Issuance or Out of State Transfers after 3:30pm.

• The TSA has postponed the REAL ID requirement to May 7, 2025.

• You have 30 days before and 60 days after the expiration date on your license to renew.

• You may also go onto the [www.iowadot.gov](http://www.iowadot.gov) website to see if you are eligible for online renewal, Skip the Trip at Home Permit testing applications and the list of documents required for the Real ID.

• To take a permit test if you are a citizen of the US and under the age of 18, you will need to provide a state or county issued birth certificate, a hospital copy is NOT acceptable, an actual social security card and a parent. If you are not a citizen and under the age of 18, we will need INS documentation, social security card and a parent with a valid Iowa driver's license or Iowa identification card.

• CDL HOLDERS MUST PROVIDE ADDITIONAL INFORMATION FOR RENEWAL, CALL FOR DETAILS!

• Address changes: You must report a change of address to the DOT within 30 days. The cost is \$10.00 if your license is not up for renewal.

• If you have a cracked card and there are no other changes, you can come in for a FREE duplicate.

• If you are just moving into Iowa from another state, please stop by and get a list of the proper identification and a list of documents you can bring in for proof of residency.
