Mark Leonard of Holstein addressed Ida County Republicans prior to the official start of the party's caucus in Holstein on Feb. 3. According to the Iowa Republican Party website, Ida Republicans cast 133 votes for President Donald Trump, one vote for William Weld and one vote was listed in the other candidate's category.

Ida County Democrats gathered in two locations, Holstein and Ida Grove, for their presidential year caucus on Feb. 3. Caucus goers at the Ida Grove location listened to a speaker prior to selecting their favorite candidates. According to the Iowa Democratic Party website, Ida County Democrats favored Pete Buttigieg with 58 votes. He was followed by Joe Biden, 48; Amy Klobuchar, 25; Bernie Sanders, 12; Elizabeth Warren, one: and uncommitted.

The Ridge View boys' basketball team won two of its three games last week to close out the regular season with a 17-4 record.

The Odebolt-Arthur Education Association presented its contract proposal to the school board on Feb. 8, asking for a \$1,300 increase in the base salary. The proposed increase would raise the base salary to \$25,250.

The Battle Creek City Council voted against re-entering countywide law during a special meeting. The city's share of countywide law, if it re-entered, would be \$49,096. Battle Creek Police Chief Brian Thompson's proposed budget for the next fiscal year is \$51,270 plus additional costs for insurance.

The Ida Grove City Council instructed Kuehl and Payer Engineering to put together a proposal for an exploratory well drilling program along the Maple River near town, in an effort to find another, high-producing water well to replace the city's contaminated well number three. The estimate to find a new well and run piping three miles is \$300,000.

Holstein City Parks and Recreation Director Chuck Shropshire has resigned. City Clerk Dave Ehler said the city hopes to have a new director hired by March 15.

Two territories became U.S. states on Valentine's **Day.** Oregon became the 33rd state on Feb. 14, 1859, even if its residents didn't know it right away. (It took a full month for the news to travel across the country via a combination of telegraph, stagecoach, and steamship).

Exactly 53 years later on Feb. 14, 1912, Arizona became the 48th state.

In 1929, the Saint Valentine's Day Massacre happened in Chicago. Seven members of Chicago's North Side Gang were gathered at a garage on Feb. 14, 1929. They were shot by four unknown assailants, two of whom were disguised as police officers.

The murders resulted from the competition for control of organized crime in the city, during Prohibition. The largely Irish North Siders were headed by George "Bugs" Moran, and their largely Italian Chicago Outfit rivals were led by Al Capone.

The perpetrators have never been conclusively identified, but former members of a gang working for Capone are suspected of involvement.
