Marengo council renames 'public forum'

'Resident comments' is a more accurate description, officials say

MARENGO — The open forum portion of Marengo City Council meetings will now be called "resident comments.

The City Council made the change to more accurately describe what is allowed during that portion of city council meetings.

According to the Iowa League of Cities, which guides city councils through Iowa open meeting laws, the city council shouldn't discuss items other than what was on the agenda when it was posted.

The council must provide 24 hours notice to the public about what will be discussed at the meeting. If an item is added to the agenda less than 24 hours prior to a meeting or at a meeting, the public may contend that proper notice was not given.

Therefore, if someone brings up a topic during the public forum section of the meeting, the may or or presiding officer should defer the discussion and action to the next council meeting or suggest a special meeting be called if there is an immediate need to address the issue, the League of Cities says.

It is not appropriate to move forward with action on an item that was not on the agenda.

The council, city administrator, mayor and police chief have answered questions asked by the residents even after City Attorney Gage Kensler advised them not to.

Mayor Adam Rabe and City Administrator Karla Marck have reminded council members before open forum that they are not to discuss topics not on the agenda.

Open forum is not the same as a public hearing, which is required by law for certain situations, such as prior to the adoption of a budget, Iowa League of Cities says. Public hearings solicit public input on specific proposed actions.

But many cities provide a time for public comment at every meeting in order to allow residents to give feedback and have input in their city government.

Cities can make rules of conduct for their meetings to ensure the meetings are orderly, the League of Cities says. The rules can permit the council or presiding officer to establish time limits for public comments.

The mayor or presiding officer is ordinarily responsible for enforcing these rules.

The City of Marengo limits comments during open forum to three minutes and requires that speakers give their names and addresses.

Dan Nieland, Economic Development Director provided an update for county economic development. Nieland stated Pow I-80 has applied for an assessment through IEDA's Downtown Resource Center for the cities of Montezuma, Brooklyn, and Grinnell. Nieland should know by February 10 if they were approved and when the assessments will be scheduled. The program itself is an immersive exploration of the downtown by 3-4 experts that look at the positive attributes as well as the areas for improvement. This is based on observations as well as in-depth conversations with stakeholders throughout the community. It culminates in a community meeting that highlights their findings and there is a subsequent report that provides more information on what can be improved, how to do it, and where potential funding assistance can be found.

Nieland stated Jeld-Wen closed their window plant which resulted in a lay-off of 298 employees, 96 of which reside in Poweshiek County, Bolen stated even though the others do not reside within Poweshiek County will suffer from this lay-off. Nieland stated he has coordinated with lowaWORKS for a career fair to be held February 26 from 10 am to 1 pm at lowa Valley Grinnell Campus.

Tindle inquired if anything was being pursued to find a business to go into the old Sigs Manufacturing buildings. Nieland stated that it was tricky due to Dan Nieland, Economic Development

the setup of the buildings, but it is something he is pursuing. Nieland stated there have been several inquiries from businesses inquiring about locating to Poweshiek County, but those businesses are in need of larger buildings which currently are not any available and also some of the businesses require more water or electric capacity than available. Nieland is working to try and bring businesses such as a gas station to the location south of 1-80 at the Malcom exit. Nieland stated he is working on business outreach with businesses in other states to market Poweshiek County, lowa to them. Pow 1-80 is partnered with Greater Des Moines Partnership to get this information out there. Nieland stated they also partner with Alliant for business outreach they also partner with Alliant for business outreach. Lyle Brehm, Engineer; DJ Hendrix, Assistant to the Engineer; and Eric Refer, City of Victor Mayor met with board to discuss the resurfacing of F29 (Old 6 Rd) from IA21 to City of Victor. F29 is a farm-to-market route. Where the route crosses into the corporate limits of a city, the route becomes a farm-to-market extension, but Poweshiek County has had a policy for about 20 years where the county shares in the cost of the traveled portion of the roadway for projects. The cities are still responsible for all costs outside the traveled roadway, such as driveways, curb and gutter, utilities, etc. Engineer Brehm has prepared this project to include work within the city limits. Poweshiek County has prepared plans and will take bids through the lowa DOT in March. The farm-to-market fund will pay the project costs upfront. The city will reimburse the county for their costs. Historically the county has allowed the cities to repay within 5 years, which includes an interest rate. The county will need to enter into a couple of agreement will be that the county is the lead agency on the project and that the city will accept our plans and execution of the project. Iowa conifers struggle with winter burn

Iowa Department of Natural Resource foresters are anticipating reports of moderate to severe winter burn damage to arborvitae and white pine trees across Iowa.

'The ground remains frozen, but the ambient temperatures have been above freezing," explains Tivon Feeley, DNR forest health forester. "The tree is forced to use their water reserves in the needles, but can't absorb new water from the frozen soil. The lack of water causes the trees to dry

Winter burn is common on conifers planted

in open, unprotected locations exposed to severe winter weather. Symptoms include browning or bleaching of the needles, trees losing needles and tree death.

These symptoms become more apparent as the days become warmer in late spring and tend to be worse on the side of the tree exposed to sunlight or wind during the winter months.

If needles on the tree are dead but buds are alive, new plant foliage will regrow to replace the winter burned foli-

If both the buds and needles are dead, the tree will not recover. The tree will need to be removed.
