'Nutrition is one of the most important factors that must be managed well in order to reach calf crop goals,"



Lundy-Woolfolk said. "The workshop will include both classroom and hands-on learning opportunities focused on the importance of nutrition leading up to and through the breeding

Presentations will address nutrition's role in reproduction, livestock risk protection options and using ration formulation software to assess beef diets.

Presenters will also answer questions from those in attendance.

Woolfolk, presenters are Tim Christensen, ISU Extension and Outreach farm management specialist; Dan Hosch, with Zinpro, and Noah Sellner, with Nelson Farm Supply.

Wetland Field Day near Osage set for April 10

AMES — Iowa Learning Farms, in partnership with the Floyd and Mitchell County Soil and Water Conservation Districts, will host a wetland field day Thursday, April 10, from noon to 2 p.m. at the New Haven Mennonite Community Center near Osage.

The event is offered at no cost to farmers and landowners and includes a complimentary meal.

Water quality enhancement wetlands are constructed to reduce nitrogen loads from croplands to streams and rivers while also providing wildlife habitat and increased recreational opportunities.

To accelerate the installation of wetlands across the state to help meet the Iowa Nutrient Reduction Strategy goals, the Iowa Water Quality Initiative offers flexible, cost-share funding to help install wetlands in areas that do not meet other program requirements.

To date, more than 138 water quality enhancement wetlands have been Osage, and will be held

completed and 88 additional wetlands are set to begin construction in the next two or three years.

Field day attendees will have the opportunity to hear from Mitchell County landowner Myrna Hoisington about the recently completed water quality enhancement wetland constructed on her land near Orchard.

Kurt Hoeft, Iowa Drainage District Association wetland field specialist, will discuss how wetlands improve water quality and wildlife habitat. Brandon Dittman, Iowa Department of Agriculture and Land Stewardship wetlands project manager, will share how to get involved with the Water Quality Initiative and the water quality enhancement wetland program, and will share details on the construction of the wetland featured in this field day.

A walking tour of the newly completed wetland will conclude the field



New publication describes proper use of esophageal feeder

lowa State University Extension big dividends in keeping

AMES — Using an esophageal feeder is an integral part of raising cattle, yet many producers are not completely comfortable using them.

A new publication from Iowa Beef Center, "Proper Use of an Esophageal Feeder," provides step-by-step instructions on properly preparing, inserting and removing the feeder tube.

Iowa State University Extension and Outreach beef specialist Denise Schwab said correctly feeding a calf that isn't getting adequate colostrum on its own can pay more newborn calves in

"In addition to descriptive text, the publication has links to videos on using the esophageal feeder and cleaning milk feeders," she said. "There's also a simple drawing to show where the tube should go as you insert it into the calf."

Schwab, who authored this resource, suggested reading through the steps before actually needing to insert a feeder. This can help the producer gain confidence in the procedure, which can lead to better results


