Rounds, memberships increase at **Bos Landen**

Since the City of Pella took control of the Bos Landen Golf Course two years ago, the course has seen increases in individual rounds and course memberships.

"The city took on the full operations of Bos Landen Golf Course, the overall of the grounds and the clubhouse operations at the beginning of 2023," Golf and Athletics Manager for the City of Pella, Kevin Vos, said during a recent Espresso TV. Prior to that, the course that opened in 1993 had been led by

various management firms. "When the city took over, there was things that have not been done, the participation rates weren't there," Vos continued. "We made a pitch to the City administration, to the city council. We were very fortunate they approved of that, and since then, in the last two years, we have seen significant growth and strides in the overall operations of Bos Landen."

According to figures presented at the March 25 Pella City Council meeting, with increased use of the facility (and increased greens fees), the City's subsidy for Bos Landen decreased from \$387,000 to around \$147,000. Vos did not expect things to change that quickly.

"It's been lot of hard work, lot of long hours, lots of meetings, but well worth it," Vos said. The course has not only found renewed life with Pella and local residents, but its name in the wider golf community has been restored. "It's great for our community. We bring in so many people from not only our community, but around surrounding communities that are traveling here and hearing such positive things. It's just been great." Vos believes a key to the success has been

said. He went on to praise Clubhouse Manager Matt Jennings and Golf Pro John Chavers.

"We've got plans, you know, going forward of what we'd like to see. We're not there yet, but, but so far so good," Vos said.

Maintaining the course's success will come at a price. Estimated capital improvement repairs at the course over the next five years will cost \$3,872,000. This includes the bulk of projects planned for FY2028, which include bunker and path repairs (\$775,000), hole 18 renovation (\$450,000) and irrigation control system replacement (\$932,000). Estimated expenditures in FY28 are \$2,391,000.

A bond referendum may be used to cover those costs, as well as \$953,000 in FY29 clubhouse/kitchen upgrades (\$643,000), a project on hole 17 and pesticide storage.
