Council approves next round of façade grants

Knoxville City The Council approved the next round of façade grants at Monday's regular meeting. They included:

112 E Robinson, \$2,747.50 for Brick Repairs 319 E Main, \$3,650 for **Brick Repairs** 109 E Main, \$2,549 for

Brick/Stucco Repairs 108 N Second, \$3,050 for Painting/Awning 116 N Second, \$775.75 for Awning 613 W Pleasant, \$10,000 for Windows/Doors 913 W Pleasant, \$10,000 for Windows/Lighting 909 W Pleasant, \$2,480.38

for Windows/Lighting These improvements have a total cost of \$78,178, of which the grants will provide \$35,253. Approximately \$54,000 remains available for façade grants.

Public Safety Complex plan coming soon

architects The of Knoxville's new public safety complex/city hall are expected to bring their plans before the city council in June.

"The architect and the engineers were given the green light right about a month ago, that we're ready to move forward," City Manager Heather Ussery said. "They have gotten those updated and I think the first meeting in June is what we're planning on for them to be on the agenda." Ussery said that the plan is to go out for precast bids

before the rest of the project to secure materials. The City does not want to wait

for those materials when it is time for construction.

"Our hope would be to go out for bid early fall/ late summer," Ussery said. "That's where the time frame is now, so we'll update council with all of that."

Miller-Meeks invites Pope to Congress

Congresswoman Mariannette Miller-Meeks (IA-01) is leading a formal letter to Speaker Mike Johnson requesting an invitation for Pope Leo XIV to address a Joint Session of Congress.

The letter comes just days after Congresswoman Miller-Meeks joined a historic congressional delegation to the Vatican for the (inaugural) Mass of Pope Leo XIV—the first

American pope—alongside Vice President JD Vance, Secretary of State Marco Rubio, and nearly 20 members of Congress.

"Pope Leo XIV represents profound moment in both American and world history," said Miller-Meeks. "His life, leadership, and message of faith are already uniting people across the globe. Whether you're Catholic or not, his message is one of human dignity,

responsibility, and truth. It would be an incredible honor for Congress and the American people to hear directly from him. At a time when the world is searching for moral clarity and renewed purpose, Congress should welcome that message."

If accepted, Pope Leo XIV would become only the second pontiff in history to address a Joint Session of Congress.

Muether earns doctorate

May 15 marked Heidelberg Seminary's Theological Annual Commencement at Trinity Reformed Church (Sioux Falls, SD). Rev. Chuck Muether of Pella, Iowa, received his Doctor of Ministry degree. It was a special occasion for Dr. Muether as the graduation speaker was Rev. Cody Schwichtenberg, his former student whom he had taught ten years ago at the seminary. Rev. Schwichtenberg's address, "Take Heed, Brothers" was drawn from the text, Acts 20:8. President Maynard Koerner presented Rev. Muether his degree. Academic Dean Dr. J.P. Mosley, Jr. presided over the ceremony. Rev. Brian Belh also earned his D.Min. along with others receiving the Master of Divinity degree.

Dr. Muether had taught language arts and drama for over ten years at Pella Christian Grade School before resuming his seminary training. He had previously earned a Master of Education degree at Dordt University. He planted Hope Reformed Presbyterian Church in Pella and then taught New

Testament Studies and Apologetics at Heidelberg Theological Seminary in Sioux Falls, SD. The church plant bug bit again with Dr. Muether starting Immanuel Reformed Fellowship, which began in Oskaloosa and then moved to Pella.

Dr. Muether has served Pella Ministerial the Association as secretary for five years and in recent years has formed Mariaska Ministries, an independent chaplaincy organization that serves the spiritual needs of the elderly living in residential communities.

She and Vander Veer have been discussing this service for "several" years now. As realtors, they offer gifts to clients when the new homeowners move in. The two have identified a disconnect among old and new residents, regarding what the community has to offer.

"We've kicked it around, and finally, this winter, I just said, 'We need to. Let's do it. Let's figure out a way to get this done. We need to get this going.' So we just started working and putting the plan together, and here we are. We launched last week, and we anticipate starting our deliveries in June."
