Pella City Council briefs

The Pella City Council met in regular session Tuesday night. Here are a few more details about the meeting and what was approved.

Spencer Councilors Carlstone and Dave Hopkins were absent.

Approved an agreement with the Spirit of Pella for the purchase of an ice rink chiller at Caldwell Park. Spirit of Pella is solely responsible for raising \$500,000 for the chiller. Tubes will run under the ice, which, according to Spirit's Bob Zylstra, should have a life expectancy of 15 years and keep the ice frozen at temps 50 degrees and below. The chiller itself should last 25 years. The City hopes to have the rink installed in summer 2026.

Approved a rezoning request from Federated Fellowship Church. The church plans to expand its parking lot and the rezoning aligns with the comprehensive plan.

Approved a resolution to authorize staff to seek bids for the Lincoln Street

Reconstruction This project includes replacement of the sanitary sewer. water main. pavement and removal pavement/driveway on Lincoln from 100 feet west of Houston to East Third. Estimated cost is \$1,073,594. A public hearing on the project is scheduled for June 17 at 6

Approved rate increases for sanitary sewer and water services. discussed during the budget discussions earlier this vear, the fees will increase July 1 and be reflected on bills due Aug. 20. The fee increases will help cover the costs to continue to maintain the City's water and wastewater systems.

Approved the budget amendment. There was a public hearing prior to this, during which no comments were made. The amendment was printed in a previous edition of the Express. This action will not raise taxes, it is just a requirement from the State.

Legislation compromises County 911 funding

through surcharges, but they are saving for major communications projects that will cost millions.

"The Marion County 911 board two years ago had \$1.3 million in fund balance," Anderson said. "After a nearly \$1 million communication project to purchase radios for our public safety agencies, our fund balance is slightly under \$500,000 with the board reserving \$300,000 of that for emergency reserve funds. This leaves approximately \$200,000 available for the service board for operations."

As demonstrated by the

graph Anderson provided, surcharge revenues that the service board uses for operations is realizing its lowest revenues in over 15 vears and revenues continue to trend downward.

"Our service board operates 100 percent off of surcharge dollars and receives no property tax funds from the Board of Supervisors," Anderson said. "The Marion County 911 Service board has been very financially responsible and remains one of a very small number of boards that still maintain their local 911 sign program without outside financial assistance. Our sign program has in excess of 17,000 signs, which are a very key piece of allowing the 911 system to function. Key point in this discussion is that the usage of the 911 funds is very restrictive. We are not allowed to use these funds for 911 Telecommunicator salaries or building infrastructure."

"Homeland Security proposed a change in the split of 911 surcharge revenues that I believe reasonable,' was very Rozenboom added. "But the locals refuse to acknowledge that a shortfall in funding for the state meant that the state could no longer adequately

maintain the 911 system. I fully understand the local PSAPs wanting to maintain their own systems, but without the state's ability to upgrade, there will be no system. I think this was a good compromise."

"Without a veto on this line item, it will be very difficult for the Marion County BOS to assist the 911 Board, as recent legislation capped their ability to grow their budgets to keep up with growth and inflation. There clearly won't be any winners locally if this is signed into law," Anderson
